With the IBM Netfinity 5000 Rack-to-Tower Conversion Kit you can convert your server from a rack model to a tower model. This book provides instructions for removing your server from a rack enclosure and installing the conversion kit on your server. For additional information about the IBM Netfinity 5000 server, consult the "Hardware Information" section of the IBM Netfinity 5000 Server Library.

# Removing the Server from the Rack Enclosure

### Before You Begin

- Read through these instructions to familiarize yourself with the installation procedure.
- Read the "Legal and Safety Information" section of the IBM Netfinity 5000 Server Library.

Note: The illustrations in this publication might be slightly different from your hardware.

If your server is already removed from the rack enclosure, go to "Installing the Conversion Kit on the Server" on page 5.

### **CAUTION:**

Use safe lifting practices when lifting your machine.

**Note:** Two people might be required to perform this procedure.

- 1. Open the rack front and rear doors.
- 2. Prepare the server for removal.
  - a. Shut down the server operating system.
  - b. Remove all media (diskettes, CDs, optical discs, or tapes) from the drives.
  - c. Turn off the server and any attached devices.
  - d. If you have a fax or modem attached to the server, disconnect the telephone line from the from the wall outlet and the server.

**Note:** If you are in the United Kingdom and have a modem or fax machine attached to your server, you must disconnect the telephone line from the server before unplugging any power cords (also known as power cables).



### **CAUTION:**


The Power Control button on the front of the server does not turn off the electrical current supplied to the server. The server also might have more than one power cord. To remove all electrical current from the server, ensure that all power cords are disconnected from the power source.

- e. Disconnect all the power cords (cables) from electrical outlets.
- f. Remove the screws from each front bracket.




### 3. Remove the server from the rack enclosure.

- a. Slide the server approximately halfway out of the rack.
- b. Disconnect all cables and power cords from the rear of the server.
- c. Remove the two screws that secure the cable-management arm to the cable-arm bracket on the server.



- d. If you do not plan to install another rack model, remove the cable-management arm from the rack and store it in a safe place.
- e. Slide the server out of the rack until the slide-bracket assemblies lock.


f. Press the safety release latch on each slide rail.



- g. Lift the server slightly and carefully slide it out of the slide-bracket assemblies.
- h. Place the server on a flat, nonconductive surface.
- 4. Continue with "Installing the Conversion Kit on the Server" on page 5.


# Installing the Conversion Kit on the Server

1. Using a pen or pencil, write the bay numbers of the hard disk drives on the drives (1 to 5, from top to bottom), as indicated in the following illustration. For example, if you have only three drives, installed in bays 2, 3, and 4, they would be numbered 2, 3, and 4 respectively.




### 2. Remove the slide rails.

- a. Remove the three screws on each side that hold the slide rails.
- b. Remove the slide rails from the server.




## 3. Remove the cable-arm bracket from the server.

- a. Remove the two screws that hold the cable-arm bracket; then, remove the bracket.
- b. Replace the two screws you removed in step 3a; these screws secure the primary power supply.



### 4. Remove the bottom cover.


- a. Position the server as illustrated below.
- b. Remove the three cover screws.



- c. Slide the cover toward the back of the server about 25 mm (1 inch); then, lift the cover off.
- d. Return the server to its previous position (top side up).

### 5. Remove the top cover.


- a. Turn counterclockwise the captive screw 1 on the back edge of the cover and slide the cover toward the rear of the server.
- b. Lift the cover off the server.




c. Keep the cover nearby, or obtain the new left-side cover from the conversion kit; you might need to refer to the service label on the inside of the cover.

## 6. Remove the chassis brackets.

- a. Remove the screws that attach the chassis brackets to each side of the server.
- b. Remove the two chassis brackets from the server.




- 7. Remove the front bezel. You will replace it later with the new bezel from the conversion kit.
  - a. Locate the blue bezel-release lever on the top of the server, in the right front corner.
  - b. Move the lever toward the right, following the curve of the lever opening.



- c. Pull the right end of the bezel away from the server front and move the bezel to the right until the bezel tabs are out of the tab openings on the server front.
- d. Store the bezel in a safe place.

## 8. Remove the electromagnetic compatibility (EMC) clips.




Use a screwdriver to pry the EMC clips from the retaining slots **1**, **2** near the top of the sides, or follow these steps:

- a. From inside the server, push the hooked end of the clip toward the blade end slightly, so that you can push the hooked end through its slot opening and out of the server.
- b. Lift the clip out of the wide opening of the slot.



## 9. Install the four wire EMC clips from the conversion kit.



a. Locate the positions **3** for the wire clips; each position consists of a hole and a small slot.


b. Place the angled end of the wire clip into the hole; then, gently bend the clip and slip the other end of the wire clip into the small slot.



### 10. Install the four feet.

Note: Each foot is in two parts: the circular foot itself and a pin to hold it in place.

a. Locate the server side closest to the expansion slots; it will become the bottom of the server.




- b. Push each foot into its opening on the side of the server.
- c. From the outside of the server, push a pin through the center of each foot toward the inside of the server.
- 11. Install the base cover plate.




## **CAUTION:**

The base cover plate must be installed before the server is positioned on its feet in order to meet IEC950 safety requirements.

- a. Position the plate as shown, near the right front foot.
- b. Install the screw packaged with the plate.



- c. Position the server on its feet.
- 12. Move the operator LED panel 4 to its new location 1.




- a. Replace the existing LED panel cable with the ribbon cable from the conversion kit.
  - 1) Disconnect the cable from the back of the operator LED panel 4 and from the connector on the system board.
  - 2) Connect the system board end of the new cable to the LED panel connector (J29) on the system board (see the service label inside the cover).


**Note:** If you have difficulty connecting a cable, turn the cable connector over and try again; cable connectors are keyed to connect only one way.

b. Route the cable through the external cable duct to the new location 1 opening.

**Note:** Other cables are already routed through the duct.




- c. Install the LED panel cable clips. These clips keep the LED panel cable away from any device that might be in the top bay. It will be easier if you first remove any device that is currently in the top bay (bay A).
  - 1) Locate the following clip markings on the inside top of the server, near the front.




The open end of the wavy marks indicates the direction the open end of the clip must face. (One clip must face the open side of the server; the other clip must face the system board.)


2) Remove the adhesive backing from the clips and press them into place inside the square marks **1**, facing the direction indicated.



d. Thread the new cable through the cable clips 1, over the bezel release mechanism, and out the opening in the server front. One side of the cable connector is keyed, one side is smooth. Make sure the keyed side of the connector faces up when the cable emerges through the opening.




- e. Install the LED cable grommet.
  - 1) With the flange edges of the LED cable grommet 1 facing away from the server, clip the grommet onto the LED cable about 40 mm (1.5 inches) from the cable end 2.
  - 2) Press the right end of the grommet against the inside of the opening as shown and push the other end of the grommet into the opening until the grommet clicks into place.





- f. Install the LED panel bracket from the conversion kit.
  - 1) Push the bracket 1 tabs into the slots in the upper left corner of the server front.
  - 2) Slide the bracket away from the diskette drive until the screw hole on the base of the bracket lines up with the screw hole on the server.
  - 3) Secure the bracket with a M3.5 by 7-mm screw from the conversion kit.



- g. Remove the screws from the operator LED panel 4 and move the panel to the LED panel bracket 1.
- h. Connect the new cable to the back of the operator LED panel. Make sure the Power-On light (PWR) is at the upper left of the operator LED panel.
- i. Place the operator LED panel on the LED panel bracket you just installed 1. Ensure that the PWR LED is at the upper left. Secure the operator LED panel to the bracket with the screws you removed in step 12g, or use two M3 by 5-mm screws from the conversion kit.

## 13. Move the power-on switch panel 3 to its new location 2.


- a. Disconnect the cable for the power-on switch panel from the system board (press on the release tab on the cable plug to release it from the connector). Note the location of the cable connector before you remove it.
- b. Remove the screws from the power-on switch panel **3**; carefully remove the panel and cable from the server.
- c. Thread the power-on switch panel cable through the hole at its new location 2, and align the panel with its new location. The power-on switch button (PWR) must be on the left; the reset button (RESET) must be on the right.
- d. Install the screws for the power-on switch panel; use two M3 by 5-mm screws from the conversion kit if you prefer.
- e. Reconnect the power-on switch panel cable to the On/Off & Reset connector (J34) on the system board (see the service label inside the cover).

**Note:** If you have difficulty connecting a cable, turn the cable connector over and try again; cable connectors are keyed to connect only one way.


### 14. Install the side-cover-release latch.

Note: The latch is in two main pieces: a "button" (black piece) and a pawl (white piece).

- a. From the inside of the server, push the posts of the pawl through the latch holes 5 in the server front. Make sure the hook 11 is facing down.
- b. From the outside of the server, place the button over the posts of the pawl. Be sure to match the button end that has three ridges on the inside 12 to the pawl end that has the longer post (shorter base on the post).



- c. Install the two screws that hold the latch pieces together. Be sure that the latch slides back and forth easily.
- d. Attach the spring to the hook 13 on the edge of the server and to the latch hook 11. After you have completed the preceding steps, your server looks like this illustration.




### 15. Install the L-shaped cover.

Note: This is both the right-side cover and top cover.

- a. Align the cover with the right side of the server, about 25 mm (1 inch) from the front of the server.
- b. Place the bottom edge of the cover on the bottom rail of the right-side frame. Make sure the top of the cover is snug against the top of the server.
- c. Hold the cover against the server and slide the cover toward the front of the server until the cover stops.


**Note:** Be sure the front edge of the cover is flat against the server.

d. From the rear of the server, secure the cover to the server with four M3.5 by 7-mm screws from the conversion kit.




### 16. Prepare the hard disk drives for tower use.

- a. Remove the fan from the hard disk drive backplane. You will reinstall the fan later.
  - 1) Push the fan release lever away from the hard disk drive enclosure until the fan is free to move.
  - 2) Pull the fan away from the server about 50 mm (2 inches).




- 3) Disconnect the fan cable from the system board (press on the release tab on the fan cable plug to release it from the connector).
- 4) Remove the fan from the server. Set the fan aside.
- b. Disconnect the cables from the hard disk drive backplane.


c. Remove the screws from the front of the hard disk drive enclosure; then, pull the hard disk drive enclosure from the front of the server.




d. Move the orientation screw from the rack position 2 to the tower position 1.




- e. Swap the SCSI IDs on the hot-swap bays. Swapping SCSI IDs is accomplished by changing the A0 jumper on the hard disk drive backplane. To do this, you must first remove the daughterboard from the hard disk drive backplane.
  - 1) Release the tip of each of the three posts 1 holding the daughterboard.
  - 2) Pull the daughterboard away from the hard disk drive backplane. Set the daughterboard aside on a nonconductive surface.




3) Locate jumper block J4 on the hard disk drive backplane. Place a jumper on A0.



Note: Make sure the jumper on A2 remains in place.




- 4) Position the daughterboard on the connector and posts on the hard disk drive backplane. Press gently but firmly until the daughterboard is securely seated and the posts hold the board in place.
- f. Orient the hard disk drive enclosure for tower use.




g. Push the hard disk drive enclosure straight in to the opening in the server front.

- h. Secure the hard disk drive enclosure in place using the screws you removed in step 16c on page 16.
- i. Reconnect to the hard disk drive backplane the cables that you disconnected in step 16b on page 15.
- j. Swap the hard disk drives in the bays to correspond with the tower model bay numbering. (The hot-swap bays in a tower model are numbered 1 through 5 from left to right; move the drive that you labeled 1 (for rack-model bay 1) to what is now bay 1 in the tower, move the drive that you labeled 2 to what is now bay 2 in the tower, and so forth.)



- k. Reinstall the hard disk drive fan.
  - 1) Align the fan bracket with the fan bracket guides 1.




- 2) Push the fan bracket toward the system board about 50 mm (2 inches).
- 3) Reconnect the fan cable to the Fan 1 connector (J13) on the system board (see the service label inside the cover).

4) Push the fan bracket in until it clicks into place.

Note: Make sure no cables will be trapped or crimped by the fan bracket.

### 17. Install the front bezel that comes with this kit.

a. Align the tabs on the back of the bezel 1 with the tab openings on the front of the server.





b. Press the bezel into place until it clicks.

### 18. Install the left-side cover.

- a. Check that all cables, adapters, and other components are installed and seated correctly and that you have not left loose tools or parts inside the server.
- b. Align the left-side cover with the left side of the server, about 25 mm (1 inch) from the front of the server; place the bottom of the left-side cover on the bottom rail of the left-side frame.
- c. Insert the tabs at the top of the cover into the slots at the top of the server side.
- d. Hold the cover against the server and slide the cover toward the front of the server until the cover clicks into place.

**Note:** Be sure the front edge of the cover is flat against the server.





### Attention:

Be sure to maintain a clearance of at least 127 mm (5 inches) on the front and rear of the server to allow for air circulation.

### 19. Connect all server and device cables and connectors.

#### Notes:

- a. If you are in the United Kingdom and are going to attach a modem or fax machine to your server, you must plug in all power cords before connecting the telephone line.
- b. Wait 15 seconds after connecting the power cords to the server and the wall outlet before proceeding to the next step.

### 20. Use the server configuration program to reconfigure the server.

Because of the necessary changes to the hard disk drives, you must change the server configuration so that the Netfinity Manager program will show a graphic of a tower model for this server instead of showing a rack model.

- a. Open the server door by pushing on the small depression in the door.
- b. Press the Power-On switch to turn on the server, and watch the screen.
- c. When the messages Press F1 for Configuration/Setup and Press F2 for Diagnostics appear, Press F1.
- d. Select System Information; then select Product Data.
- e. Change the machine type and model from a rack model to a tower model.
  - 1) Find the machine type and model in the Rack column in the following table.
  - 2) Change it to the machine type and model shown in the Tower column.

Tower	Rack	
8659-12Y	8659-1SY	
8659-22Y	8659-2SY	
8659-31Y	8659-3RY	

- f. Press **Esc** to return to the main configuration utility menu.
- g. Select Save Settings; then select Exit Setup.

The Rack-to-Tower Conversion Kit installation is complete. If you choose to lock the server door, the key is inside the door.

# Appendix A. Help and Service Information

- 1. Option name and description
- 2. Proof of purchase
- 3. Server model, serial number, and manual
- 4. Exact wording of the error message (if any)
- 5. Description of the problem
- 6. Hardware and software configuration information for your system

If possible, be at your computer. Your technical support representative might want to walk you through the problem during the call.

# IBM Statement of Limited Warranty for United States, Puerto Rico, and Canada (Part 1 - General Terms)

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 may replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

Machine - IBM Netfinity 5000 Rack-to-Tower Conversion Kit

Warranty Period\* - Three Years

\*Contact your place of purchase for warranty service information. Some IBM Machines are eligible for On-site warranty service depending on the country where service is performed.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if approved by IBM to provide warranty service, will provide repair and exchange service for the Machine, without charge, under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded. The replacement may not be new, but will be in good working order.

### **Extent of Warranty**

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible.
