



Chapter 5, "Solving Problems," contains the problem symptoms and error messages that are specific to your expansion unit. This chapter also provides instructions on how to obtain service and technical assistance for your expansion unit and other IBM products that you might plan to use.

Appendix A, "Records," provides a section to record and update important information about your expansion unit, including serial number and device records. Whenever you add options to your expansion unit, be sure to update the information in this appendix.


Chapter 1. Introduction

The IBM® Netfinity® EXP10 storage expansion unit is a compact unit that provides high-capacity small computer system interface (SCSI) disk storage. It delivers fast, high-volume data transfer, retrieval, and storage functions across multiple drives, to multiple hosts. Designed for continuous, reliable service, the expansion unit's modular, redundant disk drives, power supplies, and fans use Hot-Swap logic for easy replacement without shutting down the system.

The expansion unit supports Fast Wide and Ultra SCSI for both the host and drive SCSI interfaces. The drive and host interfaces are single-ended (SE). Designed for easy installation and integration into a wide range of system environments, the expansion unit is available in a variety of configurations.

Refer to the Chapter 2, "Installation Setup" on page 13 for instructions for setting up your expansion unit.



Front Controls

Front Controls

The primary-user controls on the front of the expansion unit appear in the following illustration:



Drive Levers

Active LEDs: These green lights indicate drive activity when lit.

Power/Fault LEDs: There are twenty LEDs (two for each drive) located on the front panel above the drive bays.


- Green lights indicate the drive is installed.
- Amber lights indicate a drive failure.
- Amber and green flashing lights indicate a drive rebuild.

Drive Levers: Use the multi-purpose levers to remove, insert, and lock the drives in place.

Note: The IBM ServeRAID and ServeRAID II adapters both provide support for the amber Fault LEDs.

Rear Controls, Indicators, and Connectors

The four CRUs (Customer Replaceable Units) and one Environmental Services Monitor (ESM) board are accessible from the back of the expansion unit. These components contain several user controls, indicators, and connectors.



ESM Board User Controls

SCSI Bus Connectors: This 68-pin connector is for attaching your SCSI cables.

Option Switches: Use these switches for selecting drive options.


Power LED: This green light glows when there is power to the ESM board.

Fault LED: This amber light glows if the expansion unit overheats.

Levers: Use the locking handles for removing and inserting the ESM board and the power supplies into the expansion unit.

Note: Only service technicians should remove the ESM board.

Power Supply Controls, Indicators, and Connectors



Power connectors: The power cords for the power supplies connect here.

Power Switches: Use these switches to turn the power supplies on and off.

Power LEDs: These green LEDs glow when the power switches are turned on.

Fault LEDs: These amber LEDs glow after a power supply failure.

Levers: Use the locking handles to remove or install power supplies.


Attention: Always follow these instructions when installing or removing a hot-swap power supply.

To install a hot-swap power supply:

- 1. Ensure that the AC power switch on the power supply is in the Off position.
- 2. Install the power supply in the expansion unit.
 - a. Slide the power supply into the expansion unit. The LEDs should always be on the right side.
 - b. Close the lever until it locks in place.
- 3. Connect the power cord to the power supply.
- 4. Wrap the clamp around the power cord about eight inches from the end.
- 5. Re-attach the nut and tighten securely.
- 6. Plug the supply power cord into a properly grounded electrical outlet.
- 7. Turn the switch on the power supply to the On position.

To remove a hot-swap power supply:

- 1. Turn the switch on the power supply to the Off position.
- 2. Unplug the supply power cord from the electrical outlet.
- 3. Disconnect the power cord from the power supply.
- 4. Remove the nut and clamp from the rear of the power supply.
- 5. Remove the power supply from the expansion unit.
 - a. Grasp the power supply's pull-ring and squeeze the latch to release it.
 - b. Pull the lever open and remove the power supply.



Fan User Controls and Indicators

Fault LEDs: These amber LEDs glow during fan failures.

Latches and handles: Use the latches and handles to remove or install the fans.

Attention: The fans in your expansion unit pull in fresh air and force out hot air. These fans are hot swap redundant, however, when one fan fails, the fan unit needs to be replaced within 48 hours in order to maintain redundancy and optimum cooling. When replacing the failed unit with the new fan unit, insure that this operation is performed in less than 10 minutes to prevent any overheating due to the lack of the additional fans.



The following illustrations show the location of the bays in your expansion unit. For information on installing and replacing devices in these bays, refer to Chapter 4, "Installing and Replacing Devices" on page 37.

Hot-Swap Drive Bays: The expansion unit supports up to ten Ultra SCSI hard disk drives.

Hot-Swap Drive Bays



Hot-Swap Fan Bays: Your expansion unit has two interchangeable hot-swap fan units. If one fan fails, the second fan continues to operate. Each unit contains two fans.

ESM Board Bay: The Environmental Services Monitor (ESM) board provides a SCSI interface to the drives, and monitors the overall status of the expansion unit. It is mounted in a field replaceable unit (FRU), a component designed for servicing by qualified service technicians only.

Hot-Swap Power Supply Bays: Your expansion unit has two interchangeable hot-swap power supplies.



Hot Swap Power Supply Bays

Note: The hot-swap feature enables you to remove and replace hard disk drives, power supplies, and fans without turning off the expansion unit.

Preparatory Tasks and Assumptions

The instructions in this book assume:

- You are installing the expansion unit in a 19-inch wide, rack-mount cabinet. The cabinet might also contain:
 - Industry standard EIA railing inside the cabinet for mounting the hardware
 - One or two independent power sources (distribution boxes, uninterruptible power supply, and so on.)
 - A host controller unit
 - Additional expansion units
- You already installed the other components in the cabinet, and moved the cabinet near its permanent operating location.
- You already installed the host controllers and appropriate host adapters.
- Wide SCSI bus cables are attached to the host controllers and are ready for final connection to the expansion unit.
- The cabinet and installation site meet all area, environmental, power, and site requirements for the expansion unit. Refer to the expansion unit's requirements listed in Chapter 3, "Rack Installation" on page 25.

Preparing the Cabinet

This section contains information about power cord routing and support rail installation.

Power Cord Routing Information

The expansion unit uses two power cords. You can connect these power cords to the primary power units inside the cabinet (such as an A.C. distribution unit or uninterruptible power supply (UPS)), or to an external source (such as remote power units, a UPS, or wall outlet). Both power cords can use the same power source or independent ones, as long as they meet the power requirements defined in Table 1 on page 26.

Because of the limited space in some cabinets, it might be easier to connect and route cables before you install the mounting brackets and hardware devices. If you intend to connect the expansion unit to the cabinet's internal power unit, consider connecting and routing the expansion unit power cords in the cabinet before you install the expansion unit.

Support Rail Installation Information

To install the expansion unit in a rack-mount cabinet, use the mounting hardware (provided with your hardware kit) to:

- Provide a level, stable support for the expansion unit's chassis
- Support the expansion unit's weight
- Properly position the expansion unit in the cabinet to allow proper air circulation around and through the expansion unit

The exact placement of the mounting hardware in the cabinet will depend on how your cabinet is constructed and where (vertically) you intend to install the expansion unit.

Use this procedure to setup the cabinet and prepare to install the expansion unit.

Note: During this installation, you might need to access the interior of the cabinet to attach mounting hardware or to route power and SCSI cables. As well, you must have enough room

around the outside of the cabinet to lift and install the expansion unit into the cabinet. Three U level spacing is required to install the expansion unit in the cabinet.

- 1. Turn off the power.
 - *Note:* If applicable, make sure that all main power switches in the cabinet are turned off. If the cabinet does not have a master circuit breaker that disables all incoming power, unplug the cabinet's primary power cable from the external A.C. power source.
- 2. As necessary, remove the front, back, and side panels (or doors) from the cabinet.
 - *Note:* Removing the exterior panels (or doors) from the cabinet might make it easier to install the hardware.
 - a. Retrieve the power cords from the expansion unit's shipping container.
 - *Note:* The expansion unit is shipped with two, identical power cords.
 - b. Determine the power-up sequence for your system.
 - *Note:* Read your hardware and software documentation provided with the devices (in the cabinet and on the SCSI buses) that you intend to power-up with the expansion unit. Find the information regarding the start-up procedure for each device. Based on this information, determine the sequence in which you must turn on the expansion unit and other devices in the cabinet or attached to the SCSI buses in this system.
- 3. Plug the power cords into the properly grounded electrical outlets.
 - *Note:* Plug the power cords into the appropriate A.C. electrical outlets inside the cabinet, or into an external UPS or receptacle. If the A.C. power source has several outlets, make sure that you plug the power cords into outlets that power up at the same time.


- 4. Route the other ends of the power cords so that they are easily accessible to the rear of the expansion unit once it is installed.
- 5. Install the mounting hardware.
 - *Note:* Make sure that there is enough open space above the mounting hardware to accommodate the expansion unit and to provide sufficient airflow. See Chapter 3, "Rack Installation" on page 25 for instructions on mounting hardware.
- 6. Complete all other preparations.
 - *Note:* Perform all other preparatory tasks that might be necessary to ensure that the cabinet is ready for this installation (such as installing other hardware devices, cabling, or power units).

Preparing the Expansion Unit

This section explains how to prepare the expansion unit for installation by removing the internal drives and setting the interface options.

Expansion Unit Preparation Information

It is easier to lift the expansion unit and set it onto the support rails in the cabinet if you remove all Customer Replaceable Units (CRUs) first. A fully loaded expansion unit weighs approximately 39 kg (86 lb). If you remove all the CRUs, you can reduce the overall weight.




- *Note:* The expansion unit is shipped with the decorative bezel attached to the front of the unit with two white screws and nuts in order to protect the light pipes located above the trays.
 - Before you begin –
 - Read "Handling Static-Sensitive Devices" on page 39.
 - If you have data stored on the drives, label the drives before you remove them. You must replace the drives in the exact slots from which you removed them.

The following are CRUs in your expansion unit.

- Up to ten drives
- Two power supplies
- Two fan units

See the illustration on the next page for instructions on how to remove the CRUs from the expansion unit.



Set the Expansion Unit Interface Options

There is a set of Option switches located on the back of the expansion unit. You can use these switches to select interface options. Drive SCSI IDs identify each drive in the expansion unit.


The default settings are as follows:

- SCSI IDs = (0-4) for SCSI bus 1 (switch 1 default off)
- SCSI IDs = (8-12) for SCSI bus 2 (switch 2 default on)
- Adapter control to power up disk drives (switch 3 default on)

These default settings support configurations of either a single ten drive SCSI bus or as two independent SCSI buses. All IBM SCSI controllers will selectively power up disk drives under software control. This is the preferred method to power up disk drives.

If configuring the IBM Netfinity EXP10 with two independent SCSI buses the switches (1 and 2) may be set to either position. If configuring the IBM Netfinity EXP10 with a single SCSI bus, the switches (1 and 2) should be set to opposite states. The default is switch 1 off and switch 2 on.

Note: Switches 4 and 5, and the Tray ID switch are not supported.



Chapter 3. Rack Installation

This chapter provides instructions for installing an IBM Netfinity EXP10 storage expansion unit in a rack.

Your expansion unit comes with a Rack Mount Kit. Review the preinstallation information in "Before You Begin"; then, continue with "Installing the Expansion Unit in a Rack" on page 27.

Before You Begin

• You will need a flat-blade or a phillips screwdriver.

Note: Some of the installation procedures require three people.

- Review the safety and handling guidelines specified under "Safety Information" on page v. These guidelines will help you work safely while working with your expansion unit and options.
- Review the documentation that comes with your rack enclosure for safety or cabling considerations. Ensure that your planned installation is within the rack's guidelines for heat generation, electrical requirements, air flow, and mechanical loading.
- To ensure cabinet stability, plan the installation of servers and expansion units in the rack starting from the bottom.
- Verify that the rack can meet the operating parameters, as detailed in Table 1 on page 26.




In this section, you will use right and left rail assembly brackets and eight (black) hex head screws (provided with your hardware kit).




Note: If your rack has round mounting holes, the upper and lower alignment pins must be removed and can be discarded.

To install the expansion unit into a rack with square or round mounting holes:

- 1. Move to the rear of the rack as shown below.
- 2. Locate the desired position on the rack based on the even EIA (U level) space.




- 3. Align the rail assembly to the rack.
 - a. Install two of the eight (black) hex head screws **1** (provided with your hardware kit) in the top and bottom positions, starting with the top.
 - b. Loosely tighten the screws.




- 4. Loosen the five screws (four large screws and one small screw)
 2 located on the interior of the rail assembly; then slide the front rail assembly forward
 3 until it makes contact with the front rack rail.
 - *Note:* Make sure the front rail position matches the rear rail position.
- 5. From the front of the rack, mount one (black) hex head screw4 into the bottom position of the rail assembly and tighten firmly.
 - *Note:* Before tightening, make sure the pins are located correctly in the rail holes.

- 6. Tighten the screws firmly on the rear of the rack and the four interior screws on the rail assembly.
- 7. Repeat the rail assembly procedure on the opposite side of the rack.
- 8. Remove the two small 6-32 screws **1** on the interior side of the rails.

- 9. Slide the expansion unit into the rack.


- a. Remove and discard the two white screws and nuts 2
 from the decorative bezel 1 on the front of the expansion unit.
 - *Note:* Carefully attach the bezel to the front of the expansion unit. The decorative bezel is mounted correctly when the alignment pins match with the holes in the expansion unit.



10. Insert the remaining two (black) hex head screws **2**, one on each side, and hand tighten.

Note: When starting screws, be careful not to cross-threads.

- 11. Move to the rear of the rack:
 - a. From the rear of the rack, re-insert the two 6-32 screws **1** on the rear of the expansion unit.
 - b. Tighten the screws firmly.



- 12. Connect the power cord into the rear of each power supply. Remove the nut and wrap the clamp around the line cord approximately eight inches from the end. Re-attach the nut and tighten securely.
 - *Note:* The purpose of this clamp is to prevent the accidental unplugging of the power cord from the power supply.
- 13. Install the CRUs.
 - *Note:* Refer to Chapter 4, "Installing and Replacing Devices" on page 37 for instructions on installing the CRUs into the expansion unit.

Removing the Expansion Unit from a Rack

Removing the Expansion Unit from a Rack

There should be few reasons to remove the expansion unit from the rack since most of the CRU's use hot-swap logic. If you do need to remove the expansion unit, please remember to:

- Turn off both power supply switches on the rear of your expansion unit.
- Follow any additional installation and safety instructions that come with the rack.






- 1. Disconnect the two power supply clamps holding the power cords.
- 2. Remove the two 6-32 screws **1** from the rear of the expansion unit.

3. Remove the top (black) hex head screws **2** from each side of the decorative bezel on the front of the expansion unit.

Attention: Do not remove the bottom (black) hex head screws. These mount the rails that support your expansion unit.



4. Remove the bezel **1**.

Attention: When handling the expansion unit avoid touching the light pipes to prevent damage to your expansion unit.

5. Remove the expansion unit from the rack.

Before You Begin

Before You Begin

- Become familiar with the safety and handling guidelines specified under "Safety Information" on page v, and "Handling Static-Sensitive Devices" on page 39. These guidelines will help you work safely while working with your expansion unit.
- Make sure you have an adequate number of properly grounded electrical outlets for your expansion unit, server, monitor, and any other options you intend to install.
- Place your system in a location that is dry. Rain or spilled liquids might damage your expansion unit.
- Back up all important data before you make changes to storage devices, such as hard disk drives.

If you are installing the expansion unit in a rack, be sure that the rack provides adequate space around the expansion unit to allow the expansion unit's cooling system to work properly. Refer to the documentation that comes with the rack.

Handling Static-Sensitive Devices

Handling Static-Sensitive Devices

Static electricity, though harmless to you, can seriously damage expansion unit components or options.

Note: When you are adding an internal option, do not open the static-protective package containing the option until you are instructed to do so.

When you handle options and other expansion unit components, take these precautions to avoid damage from static electricity:

- Limit your movement. Movement can cause static electricity to build up around you.
- Always handle components carefully. Never touch any exposed circuitry.
- Prevent others from touching components.
- When you are installing a new option, touch the static-protective package containing the option to a metal expansion-slot screw or other unpainted metal surface on the expansion unit for at least two seconds. (This reduces static electricity from the package and from your body.)
- When possible, remove the option and install it directly into the expansion unit without setting the option down. When this is not possible, place the static-protective package that the option comes in on a smooth, level surface and place the option on it.
- Do not place the option on the expansion unit's covers or any metal surface.

Preparing to Add Options

Preparing to Add Options


- Before you begin
- Be sure your current system configuration is working properly.
- Read "Handling Static-Sensitive Devices" on page 39.
- You can install the expansion unit in a rack unit. Refer to the documentation that comes with the rack for additional safety and operating information.

Working with Internal Disk Drives

Drives are devices that your system uses to store and retrieve data. This section explains how you can increase the expansion unit's capacity by adding more drives and replacing existing drives with larger capacity ones.

Your expansion unit contains hardware that lets you replace a failed hard disk drive without turning off the expansion unit. Therefore, you have the advantage of continuing to operate your system while a hard disk drive is removed or installed. These drives are known as *hot-swap* drives.

All hard disk drives are housed in portable drive trays that plug directly into one of ten drive bays on the front of the expansion unit. Above each drive bay on the expansion unit's front panel, there are two LEDs, which indicate the status for that particular drive.




LED	Drive State	Definitions
Active LED	Green	Glows intermittently during read/write or inquiry operations to the drive.
Power/Fault LED	Green	Glows when there is power to the drive.
Power/Fault LED	Amber/Green	Glows to indicate a drive failure or blinks amber/green to indicate a drive rebuild is under way.

The following table summarizes the LED states on your hot-swap drives and their definitions.

Drive Numbering

There are *two SCSI channels* (1, 2) in the expansion unit. Each channel uses five SCSI ID numbers. Each disk drive within the expansion unit has a unique channel number and SCSI ID number, based on its physical location in the cabinet.

When a drive is plugged into the midplane, its channel number and SCSI ID are set automatically to the standard ID assignments. (See the illustration below.) Use the option switch on the ESM board to change the ID settings.



The first number represents the channel number and the second is the SCSI ID.

— Important information for IBM ServeRAID users: ———

The view configuration screens show bay numbers, not SCSI IDs. To calculate the bay number, add 1 to the SCSI ID.

If the two channels are 'daisy chained' using the 0.4M external SCSI cable that comes with the expansion unit, then the SCSI IDs remain the same, but the drives now are all on the same channel.

Installing Hot-Swap Drives

Here are a few things to consider when installing drives:


- **Remove empty drive trays.** Expansion unit's shipped without a full set of drives (10) contain blank drive trays in the unused drive bays. Before installing new drives, you must remove the blank trays, which should be saved for future use. Each of the ten bays must always contain either a blank tray or a tray with a disk drive.
- Install 16-bit SCSI drives.

Attention: If you are replacing a drive that is part of a RAID level 1 or RAID level 5 logical drive, ensure that you install the replacement drive in the correct bay. Failure to replace the drives in their correct bays can result in loss of data.

Installing Additional Hot-Swap Drives


Use this procedure to install additional drives in the expansion unit. You can install additional drives while the expansion unit is powered-up and running. However, you must have empty drive bays to accommodate the new drives.

- Before you begin —
- Read "Handling Static-Sensitive Devices" on page 39.
- Read the instructions that come with the internal drive.
- 1. Check for Fault LEDs. If any amber LEDs are lit, refer to Table 3 on page 66.

- 2. Remove the blank drive trays:
 - a. Pull on the bottom of the tray lever to release the lever.
 - b. Lift the lever and slide the blank tray out of the bay.
- 3. Install the drive:
 - a. Unlatch and open the lever and insert the drive into the empty bay.
 - b. Lock the lever in place.



- 4. Check for LED Faults.
 - a. When drives are ready for use, the green Active LED should be off and the Power/Fault LEDs should be glowing green.
 - b. If the Power/Fault light is amber, remove the drive from the unit and wait 10 seconds; then, re-install the drive. If your SCSI adapter is the IBM ServeRAID; go to the ServeRAID User's Guide for additional information and procedures on changing the state of the drive from the current Default state to any other state (for example, HSP, RDY, rebuild drive to ONL, and so on). The amber LED should go off within 10 seconds of the drive state change (to something other than DDD).

If your SCSI adapter is the IBM ServeRAID II, in some cases, the drive will automatically reset to either a hotspare (HSP) or be rebuilt (ONL). See the ServeRAID II User's Guide for additional information. If the state change in the ServeRAID II configuration does not change automatically (amber LED does not go off), then refer to the ServeRAID II User's Guide for directions on how to perform a manual drive state change. The amber LED should go off within 10 seconds of a drive state change (to something other than DDD).

c. Configure the drives using the appropriate disk array software.

Replacing Internal Hot-Swap Drives

Drive problems include any malfunctions that delay, interrupt, or prevent successful I/O activity between the hosts and the hard disk drives in the expansion unit. This includes transmission problems between the host controllers, the ESM board, and the drives. This section explains how to replace a failed drive.

Note: Failure to replace drives in their correct bay might result in loss of data.

Check the applicable hardware and software documentation provided with your system to see if there are restrictions regarding hard disk drive configurations. Some systems might not allow mixing different drive capacities or types within an array.

– Before you begin –

- Read "Handling Static-Sensitive Devices" on page 39.
- Turn off the expansion unit. However, if removing hot-swap drives, you can leave the expansion unit turned on.
- Determine the location of the drive that you want to remove.
- 1. Remove the drive.
 - a. Pull on the bottom of the drive lever to release the lever.
 - b. Lift the lever and pull the drive partially out of the bay.
 - c. Wait at least ten seconds before fully removing the drive from the expansion unit to allow for spin down.
- 2. Install the new drive.
 - a. Unlatch and open the drive lever and insert the drive.
 - b. Lock the lever in place.
- 3. Check the LEDs.
 - a. When drives are ready for use, the green Active LEDs should be off and the Power/Fault LEDS should be glowing green.

b. If the Power/Fault light is amber, lift the lever and pull the drive partially out of the bay. Wait at least ten seconds before fully removing the drive from the expansion unit to allow for spin down. If your SCSI adapter is the IBM ServeRAID; go to the ServeRAID User's Guide for additional information and procedures on changing the state of the drive from the current Default state to any other state (for example, HSP, RDY, rebuild drive to ONL, and so on). The amber LED should go off within 10 seconds of the drive state change (to something other than DDD).

If your SCSI adapter is the IBM ServeRAID II, in some cases, the drive will automatically reset to either a hotspare (HSP) or be rebuilt (ONL). See the ServeRAID II User's Guide for additional information. If the state change in the ServeRAID II configuration does not change automatically (amber LED does not go off), then refer to the ServeRAID II User's Guide for directions on how to perform a manual drive state change. The amber LED should go off within 10 seconds of a drive state change (to something other than DDD).



Working with SCSI Components

This section contains information about SCSI configurations and cable restrictions.

SCSI Configurations

The IBM Netfinity EXP10 comes with an electronics board that interfaces between the external SCSI cables and the hot-swap backplane. There are a total of four 68-pin standard SCSI connectors. From left to right as seen from the back, these connectors are: SCSI bus 1 IN, SCSI bus 1 OUT, SCSI bus 2 IN, SCSI bus 2 OUT. There are several ways to use these buses:



• To configure both buses independently:

- 1. Attach one external SCSI cable from the controller in the server to the SCSI bus 1 IN connector.
- 2. Attach a second external SCSI cable from the controller in the server to the SCSI bus 2 IN connector.
- 3. Attach an external SCSI terminator to the SCSI bus 1 OUT connector.
 - *Note:* SCSI bus 2 OUT will come with a SCSI terminator already in place. In addition, an optional terminator is available.

Switches 1 and 2 (of 5) in the back middle of the expansion unit are used to set the SCSI IDs of the disk drives for SCSI bus 1 and 2 respectively.

- 4. Block switch positions:
 - Switch 1 off (down position): address preset for low address (0-4).
 - Switch 2 on (up position): address preset for (8-12).
 - *Note:* Switches may be left alone or for the user naming convention convenience, switch 2 may be moved down to set the addresses of bus 2 to low addressing (0-4).

• To configure the box as a single 10 drive SCSI channel:

- 1. Attach one external SCSI cable from the controller in the server to the SCSI bus 1 IN connector.
- 2. Connect a 0.4 meter 'daisy chain' cable that comes with the expansion unit into the SCSI bus 1 OUT and to the SCSI bus 2 IN connectors.
- 3. Leave the external terminator on the SCSI bus 2 OUT connector.
 - *Note:* The IBM Netfinity EXP10 comes standard with this terminator already in this position.
- 4. Keep block switches (1 and 2) in their default positions:
 - Switch 1 off (down position): address preset for low address (0-4).
 - Switch 2 on (up position): address preset for (8-12).
- To configure both buses independently for clustering:
 - 1. Attach one external SCSI cable from the controller in the server to the SCSI bus 1 IN connector.
 - 2. Attach a second external SCSI cable from the controller in the server to the SCSI bus 1 OUT connector.

Note: This completes the setup for SCSI channel 1.

- 3. Attach one external SCSI cable from the controller in the server to the SCSI bus 2 IN connector.
- 4. Attach a second external SCSI cable from the controller in the server to the SCSI bus 2 OUT connector.

Note: This completes the setup for SCSI channel 2.

- 5. The block switches should either be left in their preset state, or switch 2 can be set off (down position).
- To configure the box as a cluster of ten drives on a single channel:
 - 1. Attach one external SCSI cable from the controller in the server to the SCSI bus 1 IN connector.
 - 2. Attach a second external SCSI cable from the controller in the server to the SCSI bus 2 OUT connector.
 - 3. Connect a 0.4 meter cable to the SCSI bus 1 OUT and SCSI bus 2 IN connectors.
 - 4. Keep the switch block switches (1 and 2) in their original state:
 - Switch 1 off (down position): address preset for low address (0-4).
 - Switch 2 on (up position): address preset for (8-12).

Attention: On the switch block, switch position 3 should be on or in the up-right position. This will allow the controller to spin up the drives. Otherwise, the simultaneous load of all drives powering on could cause the power supplies to shut themselves down due to an overload condition.

Cable Restrictions

There are restrictions on the speed that a controller can communicate with the Ultra SCSI drives. Ensure that the SCSI adapter is set to the appropriate speed setting. Some adapters will default to the Ultra speed. The following table presents the cabling/speed requirements.

Note: Refer to your SCSI Adapter documentation to alter SCSI bus speeds.

Note: A SCSI channel from a SCSI adapter must be dedicated to the IBM Netfinity EXP10. This means that the corresponding internal SCSI connector must be left unused.

¹ Ultra speed is often set up in the SCSI controller by setting the transfer rate. Check your SCSI controller documentation to see how to set this parameter.

² F/W stands for 'Fast' SCSI speed and 'Wide' SCSI bus. Check with your SCSI controller documentation to see how to set this parameter.

Working with Hot-Swap Power Supplies


The power supplies are customer replaceable units (CRUs) and do not require preventive maintenance.

- Both power supplies must always be in place, even if one is not functioning properly, to maintain proper cooling.
- Replace power supplies if amber LEDs remains on.
- Refer to Table 3 on page 66 for information on LEDs.

Attention: Always follow these instructions when installing or removing a hot-swap power supply.


To install a hot-swap power supply:

1. Ensure that the AC power switch on the power supply is in the Off position.



AC Power Switches

- 2. Install the power supply in the expansion unit.
 - a. Slide the power supply into the expansion unit. The LEDs should always be on the right side.
 - b. Close the lever until it locks in place.
- 3. Connect the power cord to the power supply.




- 4. Wrap the clamp around the power cord about eight inches from the end.
- 5. Re-attach the nut and tighten securely.
- 6. Plug the supply power cord into a properly grounded electrical outlet.
- 7. Turn the switch on the power supply to the On position.

To remove a hot-swap power supply:

- 1. Turn the switch on the power supply to the Off position.
- 2. Unplug the supply power cord from the electrical outlet.
- 3. Disconnect the power cord from the power supply.
- 4. Remove the nut and clamp from the rear of the power supply.
- 5. Remove the power supply from the expansion unit.
 - a. Grasp the power supply's pull-ring and squeeze the latch to release it.
 - b. Pull the lever open and remove the power supply.

Note: When replacing a power supply due to a failure, insure that the power supply latch is mounted to the side of the supply that would be toward the middle of the machine. If not, remove the lever screw, flip the lever over and re-tighten the screw on the opposite side. (See the illustration below.)



Working with the Hot-Swap Cooling Fans


Attention: Do not run the expansion unit without adequate ventilation and cooling, because it might cause damage to the internal components and circuitry.

The fans are interchangeable and customer replaceable and do not require preventive maintenance. The fans help maintain proper air circulation across the components inside the expansion unit. Air flows through the expansion unit from the front to the back.

You can Hot-Swap the fans (replace them while the expansion unit is turned on and running), as long as you complete the exchange within 10 minutes. This time limit applies only to the total time that a fan is out of the expansion unit, beginning when you remove the failed unit and ending when you re-seat the new one. This does not include the time it takes you to perform this entire procedure (checking LEDs, unpacking the new fan, and so on).

Both fan units must always be in place, even if one is not functioning properly, to maintain proper cooling.

Note: Refer to Table 3 on page 66 for more information on LEDs.



Use the following procedures to replace a hot-swap fan:

- 1. Check the LEDs on the back of the expansion unit.
- 2. Remove the failed fan.
 - a. Slide the latch left or right to unlock the fan.
 - b. Use the handle (black knob) to pull the fan from the expansion unit.
- 3. Install the new fan.
- 4. Check the LEDs.

The Fault LEDs should turn off after a few seconds, if they remain on, refer to Table 3 on page 66.



Turning the Expansion Unit On and Off

This section contains instructions for turning the expansion unit on and off under normal and emergency circumstances.

Note: If you are turning on the expansion unit after an emergency shutdown or power outage, refer to "Restore Power After an Emergency" on page 63.

AC Power Switches



Turning the Power On

Use this procedure to turn on the power.

- Initial start-up:
 - 1. Verify that:
 - a. All communication and power cables are plugged into the back of the expansion unit.
 - b. All hard disk drives are locked securely in place.
 - c. The Option switch on the expansion unit is set correctly.
 - d. The host controller and other SCSI bus devices are ready for the initial power-up.
 - e. Check the system documentation for all the hardware devices you intend to power-up and determine the proper start up sequence.

Turning the Expansion Unit On and Off

- *Note:* In general, the IBM Netfinity EXP10 should be powered on prior to or at the same time as the system unit.
- 2. Turn on the power to each device, based on this power-up sequence.
- 3. Turn on *both* power supply switches on the back of the expansion unit.
 - *Note:* The expansion unit may take a few seconds to power-up. During this time, you may see the amber and green LEDs on the expansion unit turn on and off intermittently. When the power-up sequence is complete, only the green LEDs should remain glowing. If you still have one or more amber LEDs glowing, refer to Table 3 on page 66.
- Re-starting:

If you are re-starting after a normal shutdown, wait at least ten seconds before you attempt to turn on *both* power supply switches.

Turning the Expansion Unit On and Off

Turning the Power Off

Attention: Except in an emergency, never turn off the power if any Fault LEDs are lit on the expansion unit, especially on the drives. You should correct the fault before you attempt to turn off the power, using the proper troubleshooting or servicing procedure. This will ensure that the expansion unit will power up correctly later. For guidance, refer to Table 3 on page 66.

The expansion unit is designed to run continuously, 24 hours a day. Once you turn on the expansion unit, it should remain on. The only time you should turn off the power is when:

- Instructions in a hardware or software procedure require you to turn off the power.
- A factory representative or service technician tells you to turn off the power.
- A power outage or emergency situation occurs (see "Performing an Emergency Shutdown" on page 62).

Use this procedure to turn off the power.

- 1. Make sure that all I/O activity has stopped. If applicable, logically disconnect from the host controller.
- 2. Make sure that all amber Fault LEDs are off. If any Fault LEDs are lit (drives, power supplies, or fans), correct the problem before you turn off the power. For guidance, refer to Table 3 on page 66.
- 3. Turn off *both* power supply switches on the back of the expansion unit.

Performing an Emergency Shutdown

Performing an Emergency Shutdown

Attention: Emergency situations might include: fire, flood, extreme weather conditions, or other hazardous circumstances. If a power outage or emergency situation occurs, you should always turn off all the power switches on all computing equipment. This will help safeguard your equipment from potential damage due to electrical surges when power is restored. If the expansion unit loses power unexpectedly, it may be due to a hardware failure in the power system or mid-plane (see Table 3 on page 66).

Use this procedure to shutdown during an emergency.

- 1. If you have time, stop all activity and check the LEDs (front and back). Make note of any fault LEDs that may be lit so you can correct the problem when you turn on the power again.
- 2. Turn off *both* power supply switches; then, unplug both power cords from the expansion unit.

Restore Power After an Emergency

Restore Power After an Emergency

Note: The following instructions assume that you turned off the power supply switches during an emergency situation or after a power outage occurred.

Use this procedure to restart the expansion unit after a power failure or emergency shut down.

- 1. After the emergency situation is over or power is restored to the building, check the expansion unit for damage.

- 3. Only the green LEDs on the front and back should be glowing. If one or more of the amber Fault LEDs are lit, refer to Table 3 on page 66 for instructions.
- 4. Refer to your software application to check the software status of the expansion unit.

United States, Canada and Puerto Rico

The following is the statement of limited warranty for the United States, Canada, and Puerto Rico.

International Business Machines Corporation

Statement of Limited Warranty

The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you originally purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. If you have any questions, contact IBM or your reseller.

Machine: IBM Netfinity EXP10

Warranty Period*: Limited Three-Year On-Site Service

*Contact your place of purchase for warranty service information.

Production Status

Each Machine is manufactured from new parts, or new and used parts. In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's warranty terms apply.

The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if authorized by IBM, will provide warranty service under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

For IBM or your reseller to provide warranty service for a feature, conversion, or upgrade, IBM or your reseller may require that the Machine on which it is installed be 1) for certain Machines, the designated, serial-numbered Machine and 2) at an engineering-change level compatible with the feature, conversion, or upgrade. Many of these transactions involve the removal of parts and their return to IBM. You

represent that all removed parts are genuine and unaltered. A part that replaces a removed part will assume the warranty service status of the replaced part.

If a Machine does not function as warranted during the warranty period, IBM or your reseller will repair it or replace it with one that is at least functionally equivalent, without charge. The replacement may not be new, but will be in good working order. If IBM or your reseller is unable to repair or replace the Machine, you may return it to your place of purchase and your money will be refunded.

If you transfer a Machine to another user, warranty service is available to that user for the remainder of the warranty period. You should give your proof of purchase and this Statement to that user. However, for Machines which have a life-time warranty, this warranty is not transferable.

Warranty Service

To obtain warranty service for the Machine, you should contact your reseller or call IBM. In the United States, call IBM at **1-800-772-2227**. In Canada, call IBM at **1-800-565-3344**. You may be required to present proof of purchase.

IBM or your reseller will provide certain types of repair and exchange service, either at your location or at IBM's or your reseller's service center, to restore a Machine to good working order.

When a type of service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item. Before IBM or your reseller exchanges a Machine or part, you agree to remove all features, parts, options, alterations, and attachments not under warranty service. You also agree to ensure that the Machine is free of any legal obligations or restrictions that prevent its exchange.

You agree to:

 obtain authorization from the owner to have IBM or your reseller service a Machine that you do not own; and

2. where applicable, before service is provided —

- a. follow the problem determination, problem analysis, and service request procedures that IBM or your reseller provide,
- b. secure all programs, data, and funds contained in a Machine, and
- c. inform IBM or your reseller of changes in a Machine's location.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Extent of Warranty

IBM does not warrant uninterrupted or error-free operation of a Machine.

The warranties may be voided by misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, removal or alteration of Machine or parts identification labels, or failure caused by a product for which IBM is not responsible.

THESE WARRANTIES REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

Limitation of Liability

Circumstances may arise where, because of a default on IBM's part or other liability you are entitled to recover damages from IBM. In each such instance, regardless of the basis on which you are entitled to claim damages from IBM (including fundamental breach, negligence, misrepresentation, or other contract or tort claim), IBM is liable only for:

UNDER NO CIRCUMSTANCES IS IBM LIABLE FOR ANY OF THE FOLLOWING: 1) THIRD-PARTY CLAIMS AGAINST YOU FOR LOSSES OR DAMAGES (OTHER THAN THOSE UNDER THE FIRST ITEM LISTED ABOVE); 2) LOSS OF, OR DAMAGE TO, YOUR RECORDS OR DATA; OR 3) SPECIAL, INCIDENTAL, OR INDIRECT DAMAGES OR FOR ANY ECONOMIC CONSEQUENTIAL DAMAGES (INCLUDING LOST PROFITS OR SAVINGS), EVEN IF IBM OR YOUR RESELLER IS INFORMED OF THEIR POSSIBILITY. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU.

If this product is not in good working order, IBM will, at its option, repair or replace this product at no additional charge except as set forth below. Repair parts and replacement products will be provided on an exchange basis and will be either new, equivalent to new or reconditioned. All replaced parts and products become the property of IBM. This warranty does not cover the repair of damage to the product resulting from:

- · Accident, disaster, misuse and abuse
- Use of parts not manufactured or sold by IBM
- Modification of the product
- Service provided by anyone other than IBM or an authorised IBM service provider.

IBM does not warrant that the functions in any preloaded program will meet your requirements or that the operations of the preloaded program will be uninterrupted or error free.

There is no other warranty whether express or implied. In case the exclusion of certain warranties would be precluded by applicable law, such warranties would be limited in duration to the warranty period stated above.

Warranty Performance

Warranty service may be obtained by returning the product during warranty period to an authorised IBM service provider and by providing proof of your warranty service entitlement. You are responsible for any associated transportation charges and insurance during shipment and return.
