## About this book

This book provides instructions for installing and replacing options in your IBM Netfinity EXP200 Storage Expansion Unit. It also provides information on troubleshooting your expansion unit. If you have not yet set up your expansion unit, refer to Chapter 2, "Installing the expansion unit" on page 11 for detailed information.

## How this book is organized

Chapter 1, "Introduction," describes the expansion unit. This chapter includes an inventory checklist and an overview of the expansion unit features and components.

Chapter 2, "Installing the expansion unit," contains the information and instructions needed to install the expansion unit in an EIA standard rack, the Netfinity EXP200 Rack-to-Tower Conversion enclosure, or a Netfinity NetBAY enclosure. Operating specifications, option switch settings, and power cord routing information are also included.

Chapter 3, "Installing and replacing devices," contains step-by-step instructions for installing and removing customer replaceable units (CRUs), such as hard disk drives, power supplies, and fans. In addition, this chapter contains instructions for turning the expansion unit On and Off during normal and emergency situations.

Chapter 4, "Solving problems," contains the problem symptoms and error messages that are specific to your expansion unit. This chapter also provides instructions on how to obtain service and technical assistance for your expansion unit and other IBM products that you might plan to use.

Appendix A, "Records," provides a section to record and update important information about your expansion unit, including serial number and device records. Whenever you add options to your expansion unit, be sure to update the information in this appendix.

Appendix B, "Product warranties and notices," contains product notices, warranties, and trademarks.

# **Chapter 1. Introduction**

The IBM® Netfinity® EXP200 Expansion Unit is a compact unit that provides high-capacity small computer system interface (SCSI) disk storage. It delivers fast, high-volume data transfer, retrieval, and storage functions across multiple drives, to multiple hosts. The expansion enclosure is designed for continuous, reliable service; the modular, redundant disk drives, power supplies, and fans use hot-swap technology for easy replacement without shutting down the system.

Designed for easy installation and integration into a wide range of system environments, the expansion unit supports Ultra and Ultra2 SCSI for the host interface and Ultra2 SCSI for the drive interface.

The expansion unit comes with a limited three-year on-site warranty. In addition, the Startup Support program provides coverage to customers during the first 90 days after installation at no additional charge.<sup>1</sup> This comprehensive program enhances IBM support for setup, installation, configuration, and problem determination. In the U.S. and Puerto Rico, call IBM at 1-800-772-2227, or in Canada, call 1-800-565-3344 if you need assistance. In all other countries, contact the IBM support organization that services your area, your IBM marketing representative, or your IBM reseller.

## **Clustering support**

One of the features listed in the previous table is clustering. Clustering is a means of sharing SCSI buses and disk drives among SCSI controllers to provide redundancy of SCSI controllers and servers. This redundancy is important if a hardware component fails. If a hardware component failure occurs after clustering has been set up, then another server will take ownership of the disk drives or SCSI bus.

If IBM ServeRAID controllers are used in a cluster configuration, the termination power LED on the rear of the expansion unit is useful when servicing the cluster. The ServeRAID controller provides the term power signal. If a termination power LED is not on, it indicates that a particular EXP200 expansion unit is not attached to a powered-on controller. It is useful to know which external EXP200 expansion unit is attached to which server when the hardware is being serviced.

## Netfinity EXP200 bays


The following sections show the hot-swap and environmental services monitor (ESM) bays on the Netfinity EXP200 expansion unit.

The hot-swap features of the Netfinity EXP200 enable you to remove and replace hard disk drives, power supplies, and fans without turning off the expansion unit. Therefore, you can maintain the availability of your system while a hot-swap device is removed, installed, or replaced.

## Hot-swap drive bays

The following illustration shows the location of the hot-swap drive bays accessible from the front of your expansion unit. The EXP200 supports up to ten IBM Ultra2 SCSI hard disk drives. These drives come preinstalled in a drive tray. This drive and tray assembly is called a *drive CRU* (customer replaceable unit). You can install the drive CRUs in the 10 drive bays on the front of the expansion unit.

In this example illustration, six of the ten bays contain drive CRUs and four bays contain blank tray fillers. To maintain proper cooling within your expansion unit, always keep a blank tray filler in each drive bay that does not contain a drive CRU. For information on installing and replacing drive CRUs, refer to Chapter 3, "Installing and replacing devices" on page 27.




#### Attention:

Never hot swap a drive CRU when its green Activity LED is lit or flickering. Only hot swap a drive CRU when its amber Fault LED is lit or when the drive is inactive.

## Fan, ESM, and power supply bays

The following illustration shows the location of the hot-swap fan bays, the environmental services monitor (ESM) bay, and the hot-swap power supply bays.



**Hot-swap fan bays:** Your expansion unit has two interchangeable hot-swap and redundant fan units. If one fan unit fails, the second fan unit continues to operate. Each unit contains two fans.

**ESM bay:** The environmental services monitor (ESM) board provides a SCSI interface to the drives and monitors the overall status of the expansion unit.

#### Attention:


Removal or replacement of the ESM board must be performed by trained service personnel only.

**Hot-swap power supply bays:** Your expansion unit comes with one hot-swap power supply and one empty power supply bay into which you can install the optional redundant hot-swap power supply.

When you operate the expansion unit with only one power supply (other than while hot swapping), the power supply must be installed in the standard bay and the blank cover must be installed in the optional bay to maintain proper function and cooling within your expansion unit.

## Front controls and indicators

The primary controls on the front of the expansion unit are shown in the following illustration.



**Power-on LED:** This green light indicates that the unit has good DC power.

**General system error LED:** When lit, this amber LED indicates that the unit has a fault, such as in a power supply, fan unit, or hard disk drive.

**Drive CRU:** You can install up to 10 hot-swap drive CRUs (customer replaceable units) in the expansion unit. Each drive CRU consists of a hard disk drive and tray.

**Blank tray filler:** Expansion units shipped without a full set of drives (10) contain blank trays in the unused drive bays. Before installing new drives, you must remove the blank trays, which should be saved. Each of the 10 bays must always contain either a blank tray or a drive CRU. Each blank tray contains a filler piece for use with a slim-high drive.

**Activity LED:** Each drive CRU has an Activity LED. When flashing, this green LED indicates drive activity.

**Fault LED:** Each drive CRU has a Fault LED. When lit, this amber LED indicates a drive failure. When flashing, this amber LED indicates that a drive Identify or Rebuild is in progress.

**Latch:** This multipurpose blue latch releases or locks the drive CRU in place.


**Tray handle:** You can use this multipurpose handle to insert and remove a drive CRU in the bay.

**Note:** The IBM ServeRAID® II, ServeRAID-3H, ServeRAID-3L, ServeRAID-3HB adapters and the Netfinity Fibre Channel RAID Controller Unit provide support only for the amber Fault LEDs.

## Rear controls, indicators, and connectors

Two hot-swap power supply CRUs, two hot-swap fan CRUs, and one environmental services monitor (ESM) board are accessible from the back of the expansion unit. These components contain several user controls, indicators, and connectors.

## Power supply controls, indicators, and connectors



Levers: Use these locking handles to remove or install a power supply.

**Power LED:** This green LED is lit when the expansion unit is turned On and receiving ac power.

Fault LED: The amber Fault LED lights if a power supply failure occurs.

Power switch: Use this switch to turn the power supply On and Off.

AC Power connector: The power cord for the power supply connects here.

**Power supply CRU:** The standard hot-swap power supply is located here. Your expansion unit might also contain the optional redundant hot-swap power supply.

#### Attention:

Do not hot swap the power supply when only one supply is installed. The expansion unit power is redundant only when the optional second power supply CRU is installed.


**Optional power supply bay cover:** Your expansion unit comes with one empty power supply bay into which you can install the optional redundant hot-swap power supply. If you do not install the optional supply, you must keep this bay cover installed to maintain proper function and cooling within your expansion unit.

## Fan controls and indicators

The fans in your IBM Netfinity EXP200 are hot-swappable and redundant. This means that your IBM Netfinity EXP200 will continue to operate if a fan fails. It also means that you can remove and replace the fan while the IBM Netfinity EXP200 is On and accessing drives.

#### Attention:


The fans in your expansion unit pull in fresh air and force out hot air. These fans are hot-swappable redundant; however, when one fan fails, the fan unit must be replaced within 48 hours in order to maintain redundancy and optimum cooling. When replacing the failed unit with the new fan unit, ensure that this operation is performed in less than 10 minutes to prevent any overheating due to the lack of the additional fan unit.



Fault LEDs: These amber LEDs light when a fan failure occurs.

**Latches and handles:** Use the latches and handles to remove or install the fan CRUs.

## ESM board user controls



**ESM board:** This environmental services monitor (ESM) board contains the SCSI controls, switches, and LEDs.

#### Attention:

Removal or replacement of the ESM board must be performed by trained service personnel only.

**SCSI bus connectors:** These two 68-pin VHDCI connectors are for attaching your SCSI cables to SCSI Bus 1 and SCSI Bus 2.

**Levers:** Trained service personnel can use these levers when removing and inserting the ESM board.

**Activity LED:** This green LED flashes when there is activity on the external SCSI bus. Each external bus has a separate Activity LED.

**Option switches:** Switch 1 controls the configuration of the SCSI bus. Set the switch to the Off position to combine the two internal SCSI buses or set the switch to the On position if you want two separate five-drive SCSI buses. Switch 5 sets the expansion unit to rack or tower mode. For rack mode, set Switch 5 to the Off position. For tower mode, set Switch 5 to the On position. Switches 2, 3, and 4 are reserved and must remain set to the Off position.

**Tray number switch:** This switch sets the expansion unit ID using values of 0–9. The ID is used in conjunction with system-management software.

**Over temperature LED:** This amber LED lights if the expansion unit overheats.

**Termination power LEDs:** These green LEDs light if termination power is present. (When a termination power LED is lit, it indicates that the other end of the cable is connected to a powered-on controller.) Each external bus has a separate termination power LED.

**LVD/SE LED:** This green LED lights if the host bus is in LVD mode. (The default is LVD mode.) Each external bus has a separate LVD/SE LED.

**Power LED:** This green LED is lit when there is power to the ESM board.

## System-management software support

The IBM Netfinity EXP200 provides software alert functions through the system monitor functions provided in the IBM Netfinity Manager software.

The following alerts are supported:

- Disk drive disabled
- Power supply failure
- Fan fault
- IBM Netfinity EXP200 over temperature

This system-management software is supported on the IBM ServeRAID Adapter with Service Pack Version 2.23 or later. System-management software is also supported on the IBM ServeRAID II Adapter with Version 2.30 or later, IBM ServeRAID-3H, IBM ServeRAID-3L, and IBM ServeRAID-3HB.

Netfinity Manager Service and drive Fault LEDs are supported only by IBM ServeRAID II, IBM ServeRAID-3H, IBM ServeRAID-3L, IBM ServeRAID-3HB adapters and the Netfinity Fibre Channel Controller Unit.

# Chapter 2. Installing the expansion unit

This chapter contains the information needed to install the expansion unit. You can install the EXP200 expansion unit in the following types of enclosures:

- An EIA standard rack cabinet
- The IBM Netfinity EXP200 Rack-to-Tower Conversion Kit
- An IBM Netfinity NetBAY enclosure

You will need a flat-blade and a phillips screwdriver to install your expansion unit. Each type of enclosure comes with general installation instructions for installing optional devices.



## **Getting started**

Before you begin, review the following tasks and assumptions:

- If you are installing the expansion unit in a rack, you have already installed the other components in the rack and moved the rack to its permanent operating location.
- You have already installed and configured the host controllers and appropriate host adapters.
- There are 68-pin SCSI cables attached to the host controllers, ready for final connection to the expansion unit.
- The installation site meets all area, environmental, power, and site requirements for the expansion unit. Refer to the expansion unit requirements listed above in "Operating specifications."

## Preparing the expansion unit

This section explains how to prepare the expansion unit for installation by removing the CRUs (customer replaceable units) and by setting the interface options.

## **Removing CRUs**

It is easier to lift the expansion unit and install it in a rack or tower enclosure if you remove all CRUs (drives, fans, and power supplies) first. A fully loaded expansion unit with 10 disk drives, two fan units, and the second power supply installed weighs 36.1 kg (79.5 lbs). The standard unit shipped with one power supply and two fan units weighs 22.5 kg (49.5 lbs). If you remove all the CRUs, you can reduce the overall weight.

#### Attention:

If you have data stored on the drives, label the drives before you remove them. Then when you replace the drives, install them in the exact drive bays from which you removed them.

See Chapter 3, "Installing and replacing devices" on page 27 for the information needed to remove the CRUs.

#### CAUTION:

Use safe practices when lifting.

#### Attention:

The expansion unit is shipped with the decorative bezel attached to the front of the unit with two white screws and nuts. This bezel protects the light pipes located above the drive trays. Leave the decorative bezel in place until you are instructed to remove it during the installation process.

## Setting the interface options


There are five option switches and a rotary dial switch located on the back of the expansion unit. It is easier to set these switches before you install the expansion unit in a rack or tower enclosure.

#### Attention:

Option switch settings must always be done while the expansion unit and host server are powered off. Failure to do so will result in loss of data.

Option Switch 1 controls the SCSI bus and ID settings, and Option Switch 5 controls the rack and tower installation modes. Option Switches 2 through 4 are Reserved; leave these switches in the Off position.

The rotary dial switch has ten settings. You can use these settings (0–9) to identify the tray number for the expansion unit. System-management software, such as IBM Netfinity Manager, uses this tray number when it provides data and alerts for the expansion unit.



## SCSI bus and ID settings

When you install a drive CRU in the expansion unit, the drive tray plugs into a printed circuit board called the *midplane*. The midplane sets the SCSI bus number and ID automatically, based on the setting of Option Switch 1 and the physical location (bay) of the drive CRU.

Your expansion unit supports up to two external SCSI buses and up to two internal SCSI buses. Each internal SCSI bus uses five SCSI IDs. When you install the expansion unit, you can set Option Switch 1 on the ESM board to create two separate five drive SCSI buses, or you can leave it set as one, daisy-chained ten drive SCSI bus.

#### • Option Switch 1 set to Off:

With this default setting, all 10 disk drive bays are on a single SCSI bus. The midplane will assign the SCSI IDs for the drive bays in ascending order from left to right (rack mode) or from top to bottom (tower mode) as follows: 0, 1, 2, 3, 4, 8, 9, 10, 11, 12. The system-management SCSI accessed fault tolerant enclosure (SAF-TE) processor uses SCSI ID 15. When Option Switch 1 is set to the Off position, you can use either external cable connector.

#### Option Switch 1 set to On:

When Option Switch 1 is set to the On position, two independent internal five drive SCSI buses are created. External SCSI Bus 1 maps to internal SCSI Bus 1 and external SCSI Bus 2 maps to internal SCSI Bus 2. The midplane assigns the five internal Bus-1 bays SCSI IDs 0, 1, 2, 3, and 4; and the five internal Bus-2 bays SCSI IDs 0, 1, 2, 3, and 4. On each SCSI bus, the system-management processor uses SCSI ID 15.

#### Important information for IBM ServeRAID users:

If you are using a ServeRAID software version earlier than Version 3.50, the View Configuration screens might show SCSI IDs or bay numbers. If the data shown on the View Configuration screen begins with '0', it denotes SCSI IDs. If the data shown on the View Configuration screen begins with '1', it denotes bay numbers.

#### Rack and tower mode settings

Option Switch 5 on the ESM board is the rack and tower mode switch. Switch 5 must be in the Off position when the unit is placed in a rack and in the On position if the unit is placed in a tower. When shipped, Option Switch 5 is set to the rack (Off) position.

When Option Switch 5 is in the On position, two changes to your expansion unit will occur. First, the SCSI ID ordering will be reversed. This SCSI ID reversal provides SCSI IDs in ascending order from top to bottom, when the expansion unit is installed in a tower. Second, the general system error indicator on the front panel will be swapped with the power-on LED, placing the green power-on LED above the general-system error indicator.

#### Tray number settings

Use the rotary dial switch on the ESM board to set a tray identification number for the expansion unit. You can set a number from 0–9. System-management software, such as IBM Netfinity Manager, uses this identification number when it provides data and alerts for the expansion unit.


## Installing the expansion unit in a rack

The EXP200 expansion unit requires 3U of EIA rack mounting space. Before installing the expansion unit in your rack you must:


- Plan device installation starting from the bottom of the rack
- Refer to the rack documentation for safety and cabling considerations. Ensure that your planned installation is within the rack enclosure guidelines for heat generation, electrical requirements, air flow, and mechanical loading.
  - **Note:** Because of the limited space in some racks, it might be easier to connect and route cables before you install the mounting brackets and hardware devices.
- Position the unit in the rack to allow for proper air circulation around and through the expansion unit
- Turn off power to your rack
- Refer to the rack documentation for instructions on removing its doors and side panels

Use the rack mounting template that comes with the expansion unit to locate the rack mounting holes and install the unit into a rack cabinet. If you misplace the template, you can use the following steps to install your expansion unit:


1. Use the following illustration of front and rear rack mounting flanges to determine the appropriate rack mounting holes for installing cage nuts or clip nuts to secure your EXP200 rails.




**Note:** Use clip nuts if your rack has round holes. If your rack has square holes, you can use the rack insertion tool or a flat-blade screwdriver to install cage nuts.



2. On the rail marked "L", remove and save the small screw 1; then, loosen the four large screws 2.




- Hold the rail against the outside of the left rack mounting flange and loosely insert the front black hex screws
   .
- **4.** Extend the rail outside of the rear rack mounting flange; then, install and tighten both rear black hex screws **1**.



5. Tighten the two front screws 2; then, tighten the four large screws 3.

Repeat step 2 through step 5 to install the rail marked "R" on the right side of the rack.


6. Slide the expansion unit into the rack; then, remove and discard both white screws and wingnuts 1 from the bezel.



- 7. Align the bezel locator pins with the expansion unit; then, secure the bezel and EXP200 with two black hex screws2.
- **8.** Use the two small screws **3** (removed in step 2 on page 17) to secure the rear of the expansion unit.
- **9.** Verify that Option Switch 5 is set to Off (see "Setting the interface options" on page 14 for further device settings).
- **10.** Install hard drives, fans, and power supplies in the EXP200 expansion unit according to Chapter 3, "Installing and replacing devices" on page 27; then, return here to complete the installation.
- **11.** Continue with "Completing the installation" on page 21.

# Installing the expansion unit in a tower conversion kit

The EXP200 Rack-to-Tower Conversion Kit provides an enclosure for a single EXP200 expansion unit. Use the mounting hardware that comes with the EXP200 expansion unit to install the unit in the enclosure as follows:




- 1. Unlock and open the enclosure door.
- **2.** Turn the EXP200 expansion unit counter-clockwise onto its left side and slide it into the enclosure; then, remove the white screws and wingnuts from the EXP200 bezel.
- 3. Align the bezel locator pins with the expansion unit; then, secure the bezel and EXP200 with black hex screws 1 on the top and bottom.
- 4. Remove the two small screws from the rails that come with the EXP200 expansion unit; then, secure the rear of the expansion unit with the small screws 2 on the top and bottom.
- **5.** Verify that Option Switch 5 is set to On (see "Setting the interface options" on page 14 for further device settings).
- **6.** Install hard drives, fans, and power supplies in the EXP200 expansion unit according to Chapter 3, "Installing and replacing devices" on page 27; then, return here to complete the installation.
- 7. Continue with "Completing the installation" on page 21.

## Installing the expansion unit in a NetBAY enclosure


NetBAY enclosures are stackable and each can store a different device, such as the EXP200 expansion unit. You can also attach a server on top of the enclosure. Refer to the NetBAY documentation for details on installing other devices.

**Note:** Due to the depth of the NetBAY3E enclosure, it might be difficult to set the expansion unit option switches once installed. Verify that Option Switch 5 is set to Off and Option Switch 1 and the tray ID switch are set properly for your environment (see "Setting the interface options" on page 14 for further device settings ).



To install the expansion unit in the enclosure, use the following procedure:

- 1. Remove the rear of the enclosure 1.
- **2.** Use the following illustration to determine the appropriate enclosure mounting holes for installing cage nuts to secure your device and rails.



- 3. On the rail marked "L", remove and save the small screw 2; then, loosen the four large screws 3.
- 4. Hold the rail against the outside of the left enclosure mounting flange and loosely insert the front black hex screws4.
- 5. Extend the rail outside of the rear enclosure mounting flange; then, install and tighten both rear black hex screws5.

6. Tighten the two front screws 4; then, tighten the four large screws 3.

Repeat step 3 on page 20 through step 6 to install the rail marked "R" on the right side of the enclosure.

- 7. Slide the expansion unit into the enclosure; then, remove and discard both white screws and wingnuts 6 from the bezel.
- 8. Align the bezel locator pins with the expansion unit; then, secure the bezel and EXP200 with two black hex screws7.
- **9.** Use the two small screws **2** (removed in step 3 on page 20) to secure the rear of the expansion unit.
- **10.** Install hard drives, fans, and power supplies in the EXP200 expansion unit according to Chapter 3, "Installing and replacing devices" on page 27; then, return here to complete the installation.
- 11. Continue with "Completing the installation."

## Completing the installation

This section provides the information needed to complete the installation. Instructions for installing the identification labels and cabling the expansion unit are included.

## Installing identification labels

Your expansion unit comes with three labels: two SCSI bay ID labels and one tray ID label. Two additional SCSI bay ID labels for tower orientations come with the EXP200 Rack-to-Tower Conversion Kit.

1. Install the SCSI bay ID label:


Verify the setting of Option Switch 1. (See "Setting the interface options" on page 14 if you need more detailed information.)

- If Option Switch 1 is in the On position, continue with step 2 on page 22
- If Option Switch 1 is in the Off position, go to step 4 on page 23.

- 2. Locate the SCSI bay ID label for your configuration.
  - **Note:** The first number represents the bus number and the second number is the SCSI ID.

To install the label:

- a. Orient the label so that the printed numbers are legible from left-to-right or top-to-bottom.
- b. Peel the backing away from the adhesive side of the label.
- c. Carefully butt the edge of the ID label up against the edge of the serial number label so that the 10 printed ID numbers are centered beneath or to the right of each of the drive bays.
- d. Apply the label to the front of the unit, as shown in the following illustrations.




3. Go to step 6 on page 24.

- 4. Locate the SCSI bay ID label for your configuration.
  - **Note:** The first number represents the bus number and the second number is the SCSI ID.

To install the label:

- a. Orient the label so that the printed numbers are legible from left-to-right or top-to-bottom.
- b. Peel the backing away from the adhesive side of the label.
- c. Carefully butt the edge of the ID label up against the edge of the serial number label so that the 10 printed ID numbers are centered beneath or to the right of each of the drive bays.
- d. Apply the label to the front of the unit, as shown in the following illustrations.



5. Go to step 6 on page 24

- 6. Install the tray ID label.
  - a. Verify the setting of the tray number switch (0-9).
  - b. Apply the tray number label that matches the setting for the tray number in the blank label area directly to the left of (or below) the bay ID label.
- 7. Continue with "Cabling the expansion unit."

### Cabling the expansion unit

This section provides the SCSI and power cabling information. After you attach your SCSI and power cables, use the instructions provided in "Turning the expansion unit on and off" on page 39 for the initial startup of the expansion unit.

#### SCSI cabling information

The IBM Netfinity EXP200 comes with an ESM board (environmental services monitor) between the external SCSI cables and the hot-swap backplane. There are a total of two 68-pin SCSI Very High Density Connector Interface (VHDCI) connectors. From left to right as seen from the back, these connectors are: SCSI Bus 1 and SCSI Bus 2. (See "Rear controls, indicators, and connectors" on page 7 for the location of these connectors.) There are several ways to use these buses.

- To configure each bus independently:
  - 1. Verify that Option Switch 1 is set to the On position. (See "Setting the interface options" on page 14 for more information.)
  - 2. Attach one external SCSI cable from the controller in the server to the SCSI bus-1 connector.
  - 3. Attach a second external SCSI cable from the controller in the server to the SCSI bus-2 connector.
- To configure the expansion unit as a single 10-drive SCSI bus:
  - 1. Verify that Option Switch 1 is set to the Off position. (See "Setting the interface options" on page 14 for more information.)
  - 2. Attach one external SCSI cable from the controller in the server to either SCSI bus connector.
- To configure the expansion unit as a cluster of 10 drives on a single SCSI bus when using IBM ServeRAID adapters:
  - 1. Verify that Option Switch 1 is set to the Off position. (See "Setting the interface options" on page 14 for more information.)
  - 2. Attach one external SCSI cable from the controller in the server to the SCSI bus-1 connector.
  - 3. Attach a second external SCSI cable from the controller in the server to the SCSI bus-2 connector.

**Note:** When clustering with an IBM ServeRAID adapter, you must configure all 10 disk drives as a single SCSI bus.

- To configure the expansion unit as a cluster when using the Netfinity Fibre Channel RAID Controller:
  - 1. Configure each bus independently, or
  - 2. Configure the expansion unit as a single 10-drive SCSI bus.

## **SCSI Cable restrictions**

Controllers that are compliant with Ultra2 and that default to Low Voltage Differential (LVD) signaling), can use any external cable length offered by IBM in any clustered or nonclustered application. These adapters include the IBM ServeRAID-3H, ServeRAID-3L, ServeRAID-3HB, and the Netfinity Fibre Channel RAID Controller. Some controllers (Ultra SCSI or Fast SCSI speeds using single ended (SE) signaling) are limited to less than or equal to 2 meters (6.5 ft) of cable to operate at Ultra SCSI speeds (20 MHz or 40 MB/sec), and less than 6 meters (19.7 ft) of cable to operate at Fast SCSI speeds (10 MHz or 20 MB/sec). The speed setting is a setup operation for a SCSI controller. Refer to your SCSI controller documentation to set the appropriate speed.

**Note:** A SCSI channel from a SCSI controller must be dedicated to the IBM Netfinity EXP200. This means that the corresponding internal SCSI connector must be left unused.

#### **Power cabling**

The expansion unit uses one standard power cord. If the redundant power supply is installed, the expansion unit uses two power cords. You can connect the power cords to a primary power unit inside the rack, such as a properly grounded ac distribution unit or uninterruptible power supply (UPS), or to an external source, such as a properly grounded electrical outlet.

If you have not already done so, attach the power supply cord as follows:

- 1. Wrap the clamp around the power cord approximately 20.3 cm (8 in.) from the power supply connection end.
- 2. Attach the power supply nut and tighten it securely.
- 3. Connect the power cord to the power supply.
- 4. Plug the supply power cord into a properly grounded electrical outlet.
- 5. Go to "Turning the expansion unit on and off" on page 39 for the initial startup of the expansion unit.

This chapter provides instructions to help you install or remove customer replaceable units (CRUs), such as hot-swap drives, fans, and power supplies. This chapter also contains instructions for turning the expansion unit on and off.

## Handling static-sensitive devices

Static electricity, though harmless to you, can seriously damage expansion unit components or options.

**Note:** When you are adding an internal option, do not open the static-protective package containing the option until you are instructed to do so.

When you handle options and other expansion unit components, take these precautions to avoid damage from static electricity:

- Limit your movement. Movement can cause static electricity to build up around you.
- Always handle components carefully. Never touch any exposed circuitry.
- · Prevent others from touching components.
- When you are installing a new option, touch the static-protective package containing the option to a metal expansion-slot screw or other unpainted metal surface on the expansion unit for at least two seconds. (This reduces static electricity from the package and from your body.)
- When possible, remove the option and install it directly into the expansion unit without setting the option down. When this is not possible, place the static-protective package that the option comes in on a smooth, level surface and place the option on it.
- Do not place the option on the expansion unit's covers or any metal surface.
- When possible, wear an ESD protective ground strap.

## Working with hot-swap drives

### Before you begin

- Read the safety and handling guidelines provided in "Safety Information" on page v and "Handling static-sensitive devices" on page 28.
- Ensure that your current system configuration is working properly.
- Back up all important data before you make changes to storage devices, such as hard disk drives.

Drives are devices that your system uses to store and retrieve data. This section explains how you can increase the expansion unit capacity by adding more drives or replacing existing drives with larger capacity ones.

Before you install or remove drive CRUs, review the following information:

### • Hot-swap hardware:

Your expansion unit contains hardware that enables you to replace a failed hard disk drive without turning off the expansion unit. Therefore, you have the advantage of continuing to operate your system while a hard disk drive is removed or installed. These drives are known as *hot-swap* drives.

### • Drive CRUs:

Your expansion unit supports IBM Ultra2 SCSI hard disk drives. These IBM drives come preinstalled in a drive tray, ready for installation. (Do not detach the drive from the tray.) This drive and tray assembly is called a *drive CRU* (customer replaceable unit). You can install the drive CRUs directly into the 10 drive bays on the front of the expansion unit.

### • Drive CRU labels:

A label is provided on the front of the drive-CRU tray. Use this label to record the location information for each drive *before* you remove it. Ensure that you keep track of the drives and their corresponding bays. Also, record the location information in Table 5 on page 48. (If you re-install a drive in the wrong bay, you might lose data.)

### • Drive LEDs:

Each drive tray has two LEDs, which indicate the status for that particular drive. The drive LED states and descriptions are as follows:

LED	LED State	Definitions
Activity LED	Green/flashing	Flashes during read/write or inquiry operations to the drive.
Fault LED	Amber/flashing	Amber flashes to indicate a drive rebuild is under way, or that a drive has been identified by software.
Fault LED	Amber On	Amber is On to indicate a drive failure.

### • SCSI buses and IDs:

There are two SCSI buses (Bus 1 and Bus 2) in the expansion unit. Each bus uses five SCSI ID numbers. Each disk drive within the expansion unit has a unique SCSI bus and ID assignment, based on its physical location in the expansion unit and the setting for Option Switch 1.

The label on the front of the expansion unit shows the bus and SCSI ID numbers for the drives. The first number represents the bus number and the second number is the SCSI ID. (See "Setting the interface options" on page 14 for more information.)

### • Blank trays:

Expansion units shipped without a full set of drives (10) contain blank trays in the unused drive bays. Before installing new drives, you must remove the empty trays, which should be saved. Each of the 10 bays must always contain either a blank tray or a drive CRU. Each blank tray contains a filler piece for use with a slim-high drive.

### • Slim-high drives:


You can install slim-high hot-swap drive CRUs, which are slightly smaller in size than the standard disk drive. These drive CRUs do not fill the entire drive bay. To maintain proper air flow and cooling when you install a slim-high disk drive, you must also install one of the fillers provided in the blank trays.

## Installing hot-swap drives


Use the following procedure to install drives in the expansion unit. You can install additional drives while the expansion unit is powered up and running.

Note: If you are replacing a drive, see "Replacing hot-swap drives" on page 33.

- 1. Read the instructions that come with the drive CRU.
- 2. Check for Fault LEDs. If any amber LEDs are lit, refer to the "Troubleshooting charts" on page 44.




- 3. Determine the bay into which you want to install the drive.
- 4. Remove the blank tray.
  - a. Insert a finger into the square hole at the top of the blank tray to grip and pull the tray out of the drive bay.
  - b. Save the blank tray for later use.
- 5. Install the drive CRU:
  - Note: The hard disk drive comes with a tray already attached. Do not attempt to detach the drive 4 from the tray 3.




- a. Release the blue latch **1** on the drive CRU by pressing on the inside of the bottom of the tray handle.
- b. Pull the handle 2 on the tray out into the open position.
- c. Slide the drive CRU into the empty bay until the tray handle **2** touches the expansion unit bezel.
- d. Push the tray handle 2 down into the closed (latched) position.

- 6. If you are installing a slim-high drive, continue with step 6a. Otherwise, go to step 7 on page 33.
  - a. Locate the filler piece on the inside of the blank tray.
  - b. Pull up on the small latch **1** inside the blank tray to release the filler piece.
  - c. Tilt the filler piece up from the blank tray **2**; then, remove it from the tray as shown in the following illustration:



d. Insert the filler piece into the empty space left in the drive bay, as shown in the following illustration.



- 7. Check the drive LEDs.
  - a. When a drive is ready for use, the green Activity LED and the amber Fault LED are Off.
  - b. If the amber Fault LED is On, remove the drive from the unit and wait 10 seconds; then, reinstall the drive.

#### — ServeRAID Information ·

In some cases, the ServeRAID controller will automatically reset the drive to the Hot Spare or Rebuild state. If the drive state change does not occur automatically (amber LED stays lit), refer to your ServeRAID documentation for information about manually changing the state of the drive from the current state to another state, such as Hot Spare or Ready. The amber LED should turn Off within 10 seconds of the drive state change.

8. Configure the drive using the appropriate software.

## **Replacing hot-swap drives**

Drive problems include any malfunctions that delay, interrupt, or prevent successful I/O activity between the hosts and the hard disk drives in the expansion unit. This includes transmission problems between the host controllers, the ESM board, and the drives. This section explains how to replace a failed drive.

#### Attention:

Failure to replace the drives in their correct bays might result in loss of data. If you are replacing a drive that is part of a RAID level 1 or RAID level 5 logical drive, ensure that you install the replacement drive in the correct bay.


Check the hardware and software documentation provided with your system to see if there are restrictions regarding hard disk drive configurations. Some system SCSI configurations might not allow mixing different drive capacities or types within an array.

1. Determine the location of the drive that you want to remove.

#### Attention:

Never hot swap a drive CRU when its green Activity LED is lit or flickering. Only hot swap a drive CRU when its amber Fault LED is lit or when the drive is inactive.

- 2. Remove the drive CRU.
  - a. Press on the inside of the bottom of the tray handle to release the blue latch 1.
  - b. Pull the handle 2 on the tray 3 out into the open position.
  - c. Lift the drive CRU partially out of the bay.
  - d. To avoid possible damage to the drive **4**, wait at least 20 seconds before fully removing the drive CRU from the expansion unit to allow for the drive to spin down.



- e. Verify that there is proper identification (such as a label) on the drive CRU, then slide it completely out of the expansion unit.
- f. If you are replacing a slim-high drive, ensure that the filler piece remains in place for use with the new drive.
- 3. Install the new drive CRU.
  - a. Gently push the drive CRU into the empty bay until the tray handle **2** touches the expansion unit bezel.
  - b. Push the tray handle **2** down into the closed (latched) position.
- 4. Check the drive LEDs.
  - a. When a drive is ready for use, the green Activity LED and the amber Fault LED are Off.
  - b. If the amber Fault LED is On, remove the drive from the unit and wait 10 seconds; then, reinstall the drive.

### – ServeRAID Information

In some cases, the ServeRAID controller will automatically reset the drive to the Hot Spare or Rebuild state. If the drive state change does not occur automatically (amber LED does not turn Off), refer to your ServeRAID documentation for information about manually changing the state of the drive from the current state to another state, such as Hot Spare or Ready. The amber LED should turn Off within 10 seconds of the drive state change.

5. Return to normal operation.

## Working with hot-swap power supplies

The power supplies are customer replaceable units (CRUs) and do not require preventive maintenance.

#### Attention:


The base unit with one power supply is *not* redundant. You must install the redundant power supply option to make your unit redundant. If you unplug the standard power supply from the basic configuration without having the redundant power option installed, you will lose power to the expansion unit and you might lose data.

- The standard power supply must always be in its proper place to maintain proper expansion-unit cooling.
- · Use only the supported power supplies for your specific expansion unit.
- The power supply bay cover must remain in place to maintain proper cooling when only one power supply is installed.

### Removing a hot-swap power supply

To remove a hot-swap power supply:

1. Turn the power supply switch to the Off position.




- 2. Unplug the power supply cord from the electrical outlet.
- 3. Disconnect the power cord from the power supply.
- 4. Remove the nut and clamp from the rear of the power supply.
- 5. Remove the power supply from the expansion unit.
  - a. Grasp the pull-ring on the power supply lever and squeeze the latch to release it.
  - b. Pull the lever open and remove the power supply.

## Installing a hot-swap power supply


After the standard power supply is installed, you can install the optional power supply in the optional power supply bay. The procedure for installing this option is the same as for installing the standard power supply. However, you must remove the power supply bay cover before installing the additional supply.

**Note:** When replacing a power supply due to a failure, ensure that the power supply latch is mounted on the side of the power supply that faces the middle of the expansion unit. If not, remove the lever screw, flip the lever over and tighten the screw on the opposite side.




To install a hot-swap power supply:

- 1. Ensure that the ac power switch on the power supply you are installing is in the Off position.
- 2. If you are installing the redundant power supply option:
  - a. Grasp the pull-ring on the lever for the optional bay cover and squeeze the latch to release it.



- b. Pull the lever open and remove the bay cover.
- 3. Install the power supply in the expansion unit.
  - a. Slide the power supply into the expansion unit. Be sure the lever is pulled straight out as you slide the power supply into the expansion unit.
  - b. Close the lever until the pull-ring latch locks in place. Make sure the lever locks into place in the expansion-unit chassis.
- 4. Wrap the clamp around the power cord approximately 20.3 cm (8 in.) from the power supply connection end.
- 5. Attach the power supply nut and tighten it securely.
- 6. Connect the power cord to the power supply.



7. Plug the supply power cord into a properly grounded electrical outlet.

If you just installed a second (redundant) supply, the amber LED will light because its power switch is in the Off position.

8. Turn the power supply switch to the On position.

If you just installed a second (redundant) supply, its amber LED will turn Off and its green LED will turn On when you turn the switch to the On position.

## Working with hot-swap cooling fans

#### Attention:

Do not run the expansion unit without adequate ventilation and cooling, because it might cause damage to the internal components and circuitry.

The fans are interchangeable and customer replaceable and do not require preventive maintenance. The fans help maintain proper air circulation across the components inside the expansion unit. Air flows through the expansion unit from the front to the back.


You can hot-swap the fans (replace them while the expansion unit is turned on and running), as long as you complete the exchange within 10 minutes. This time limit applies only to the total time that a fan is out of the expansion unit, beginning when you remove the failed unit and ending when you reseat the new one. This does not include the time it takes you to perform this entire procedure (checking LEDs, unpacking the new fan, and so on).

Both fan units must always be in place, even if one is not functioning properly, to maintain proper cooling.

Use the following procedure to replace a hot-swap fan:

- 1. Check the LEDs on the back of the expansion unit.
- 2. If the amber Fault LED is On, remove the failed fan.
  - a. Slide the latch to unlock the fan CRU.
  - b. Use the handle (black knob) to pull the fan from the expansion unit.
- 3. Install the new fan unit.
  - a. Place the fan CRU in front of the fan slot.
  - b. Hold the latch open and slide the fan all the way into the slot. If the fan does not go into the bay, rotate it 180°. The latch should always be on the side closest to the center of the expansion unit.
  - c. Release the latch. If the lever remains open, pull back on the fan slightly, then push it in again until the latch snaps into place.
- 4. Check the LEDs.

The Fault LEDs turn Off after a few seconds; if they remain On, refer to the "Troubleshooting charts" on page 44.



## Turning the expansion unit on and off

This section contains instructions for turning the expansion unit on and off under normal and emergency circumstances.

If you are turning on the expansion unit after an emergency shutdown or power outage, refer to "Restoring power after an emergency" on page 41.

## Turning on the expansion unit

Use this procedure to turn on the power for the initial startup of the expansion unit.

- 1. Verify that:
  - a. All communication and power cables are plugged into the back of the expansion unit and an ac power outlet.
  - b. All hard disk drives are locked securely in place.
  - c. Option Switches 1 through 5 and the tray number switch on the expansion unit are set correctly. (See "Setting the interface options" on page 14 for more information.)
- 2. Check the system documentation for all the hardware devices you intend to turn on and determine the proper power-up sequence.
  - **Note:** Be sure to turn on the IBM Netfinity EXP200 before or at the same time as the system server.
- 3. Turn on the power to each device, based on this power-up sequence.
- 4. Turn on the power supply switch on the back of the unit. Turn on both power supply switches if you have the second power-supply option installed.

The expansion unit might take a few seconds to power up. During this time, you might see the amber and green LEDs on the expansion unit turn On and Off intermittently. When the power-up sequence is complete, only the green LEDs on the front and back should remain On. If one or more amber LEDs remain lit, refer to the "Troubleshooting charts" on page 44.

### Attention:

If you are restarting the system after a normal shutdown, wait at least 10 seconds before you attempt to turn on the power supply switches.

## Turning off the expansion unit

### Attention:

Except in an emergency, never turn off the power if any Fault LEDs are lit on the expansion unit. Correct the fault before you attempt to turn off the power, using the proper troubleshooting or servicing procedure. This will ensure that the expansion unit will power up correctly later. For guidance, refer to the "Troubleshooting charts" on page 44.

The expansion unit is designed to run continuously, 24 hours a day. Once you turn on the expansion unit, do not turn it off. Turn off the power only when:

- Instructions in a hardware or software procedure require you to turn off the power.
- A service technician tells you to turn off the power.
- A power outage or emergency situation occurs (see "Performing an emergency shutdown").

Use this procedure to turn off the power.

- 1. Make sure that all I/O activity has stopped. If applicable, disconnect from the host controller.
- 2. Make sure that all amber Fault LEDs are Off. If any Fault LEDs are lit (drives, power supplies, or fans), correct the problem before you turn off the power. For guidance, refer to the "Troubleshooting charts" on page 44.
- Turn off the appropriate power supply switch on the back on the expansion unit. Turn off both power supply switches if you have the second power supply option installed.

## Performing an emergency shutdown

### Attention:

Emergency situations might include: fire, flood, extreme weather conditions, or other hazardous circumstances. If a power outage or emergency situation occurs, always turn off all power switches on all computing equipment. This will help safeguard your equipment from potential damage due to electrical surges when power is restored. If the expansion unit loses power unexpectedly, it might be due to a hardware failure in the power system or midplane (see the "Troubleshooting charts" on page 44).

Use this procedure to shut down during an emergency.

- 1. If you have time, stop all activity and check the LEDs (front and back). Make note of any Fault LEDs that are lit so you can correct the problem when you turn on the power again.
- 2. Turn off all power supply switches; then, unplug the power cords from the expansion unit.

## Restoring power after an emergency

Use this procedure to restart the expansion unit if you turned off the power supply switches during an emergency shut down, or if a power failure or a power outage occurred.

- 1. After the emergency situation is over or power is restored to the building, check the expansion unit for damage. If there is no visible damage, continue with Step 2; otherwise, have your system serviced.
- 2. After you have checked for damage, plug in the expansion unit power cords and turn on the power switches.
- 3. Check the system documentation for the hardware devices you intend to power up and determine the proper power-up sequence.
  - **Note:** Be sure to power on the IBM Netfinity EXP200 prior to or at the same time as the system unit.
- 4. Turn on the power to each device, based on this power-up sequence.
- 5. Turn on the power supply switch on the back of the IBM Netfinity EXP200. Turn on both power supply switches if the optional power supply is installed.
- 6. Only the green LEDs on the front and back should be on. If one or more of the amber Fault LEDs are on, refer to the "Troubleshooting charts" on page 44 for instructions.
- 7. Use your installed software application as appropriate to check the status of the expansion unit.

# Chapter 4. Solving problems

This chapter contains information to help you solve some of the simpler problems you might have with your expansion unit. It contains the problem symptoms and error messages along with suggested actions to take to resolve the problem.

This chapter also provides instructions on how to obtain service and technical assistance for your expansion unit and other IBM products that you might plan to use.

If you already have run the server test program, or if running the test does not reveal the problem, have the system serviced.

This Statement of Limited Warranty includes Part 1 - General Terms and Part 2 - Country-unique Terms. The terms of Part 2 may replace or modify those of Part 1. The warranties provided by IBM in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale, from IBM or your reseller. The term "Machine" means an IBM machine, its features, conversions, upgrades, elements, or accessories, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Unless IBM specifies otherwise, the following warranties apply only in the country where you acquire the Machine. Nothing in this Statement of Warranty affects any statutory rights of consumers that cannot be waived or limited by contract. If you have any questions, contact IBM or your reseller.

Warranty Period\* - Limited Three-Year On-Site Service

\*Contact your place of purchase for warranty service information. Some IBM Machines are eligible for On-site warranty service depending on the country where service is performed.

#### The IBM Warranty for Machines

IBM warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to IBM's Official Published Specifications. The warranty period for a Machine is a specified, fixed period commencing on its Date of Installation. The date on your sales receipt is the Date of Installation, unless IBM or your reseller informs you otherwise.

During the warranty period IBM or your reseller, if approved by IBM to provide warranty service, will provide repair and exchange service for the Machine, without charge, under the type of service designated for the Machine and will manage and install engineering changes that apply to the Machine.

If a Machine does not function as warranted during the warranty period, and IBM or your reseller are unable to either 1) make it do so or 2) replace it with one that is at least functionally equivalent, you may return it to your place of purchase and your money will be refunded. The replacement may not be new, but will be in good working order.

#### **Extent of Warranty**

The warranty does not cover the repair or exchange of a Machine resulting from misuse, accident, modification, unsuitable physical or operating environment, improper maintenance by you, or failure caused by a product for which IBM is not responsible. The warranty is voided by removal or alteration of Machine or parts identification labels.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THESE WARRANTIES GIVE YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM JURISDICTION TO JURISDICTION. SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION OR LIMITATION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD.

#### Items Not Covered by Warranty

IBM does not warrant uninterrupted or error-free operation of a Machine.

Unless specified otherwise, IBM provides non-IBM machines WITHOUT WARRANTIES OF ANY KIND.

Any technical or other support provided for a Machine under warranty, such as assistance via telephone with "how-to" questions and those regarding Machine set-up and installation, will be provided **WITHOUT WARRANTIES OF ANY KIND.** 

#### Warranty Service

To obtain warranty service for the Machine, contact your reseller or IBM. In the United States, call IBM at 1-800-772-2227. In Canada, call IBM at 1-800-565-3344. You may be required to present proof of purchase.

IBM or your reseller provides certain types of repair and exchange service, either at your location or at a service center, to keep Machines in, or restore them to, conformance with their Specifications. IBM or your reseller will inform you of the available types of service for a Machine based on its country of installation. IBM may repair the failing Machine or exchange it at its discretion.

When warranty service involves the exchange of a Machine or part, the item IBM or your reseller replaces becomes its property and the replacement becomes yours. You represent that all removed items are genuine and unaltered. The replacement may not be new, but will be in good working order and at least functionally equivalent to the item replaced. The replacement assumes the warranty service status of the replaced item.

IBM is responsible for loss of, or damage to, your Machine while it is 1) in IBM's possession or 2) in transit in those cases where IBM is responsible for the transportation charges.

Neither IBM nor your reseller is responsible for any of your confidential, proprietary or personal information contained in a Machine which you return to IBM or your reseller for any reason. You should remove all such information from the Machine prior to its return.

#### **Production Status**

Each IBM Machine is manufactured from new parts, or new and used parts. In some cases, the Machine may not be new and may have been previously installed. Regardless of the Machine's production status, IBM's appropriate warranty terms apply.

#### Limitation of Liability

Circumstances may arise where, because of a default on IBM's part or other liability, you are entitled to recover damages from IBM.
