If you need additional storage, the IBM 7131 Multi-Storage Tower Model 405 is a stand-alone storage tower that provides IBM's latest Serial Storage Architecture (SSA) hard disk drives. The 7131-405 is a leading-edge, second-generation serial storage subsystem. It uses the industry-standard Serial Storage Architecture to deliver outstanding performance and capacity/footprint, improved connectivity and availability, and enhanced attachability at a lower cost:

- Performance Improvements¹
 - Enhanced sustained data rate (up to 35MB/sec)
 - Greater attachment bandwidth (up to 80MB/sec/loop)
- Outstanding Capacity/Footprint¹
 - Eight times increase in density
 - Two times increase in disk drive capacity (up to 4.5GB/drive)

Part of the IBM StorageSmart™ family of products, the 7131 Multi-Storage Tower is sold configured with two of IBM's highest performance and capacity SSA Hot Swappable hard disk drives: either two 1.1GB, two 2.2GB or two 4.5GB IBM disk drives. The tower is also configured with three additional "hot swap" slots. These additional slots may be filled by the customer at the time of purchase, or later as needed to keep pace with the customer's storage needs.

The "hot swappable" slots can contain a mix of the following IBM SSA hard disk drives²:

- 1.1GB disk drive
- 2.2GB disk drive
- 4.5GB disk drive

In total, the tower provides up to 22.5GB of storage in a compact space. Using two towers, a customer can mirror data to provide a low-cost, back-up solution for critical environments.

- Only one of the two pairs of connectors on an adapter card can be connected in a particular SSA loop.
- A maximum of 3 neighboring dummy disk drive modules can be connected in particular SSA loop.
- A maximum of 2 adapter-connector pairs can be connected in a particular SSA loop.
- A maximum of 2 adapters, that are connected in a particular SSA loop, can be installed in a single host system unit.
