## Safety Information

#### DANGER

An electrical outlet that is not correctly wired could place hazardous voltage on metal parts of the system or the devices that attach to the system. It is the responsibility of the customer to ensure that the outlet is correctly wired and grounded to prevent an electrical shock.

## Handling Static-Sensitive Devices

**Attention:** Static electricity can damage the device and your system unit. To avoid damage, keep this device in its anti-static protective bag until you are ready to install it. To reduce the possibility of electrostatic discharge, follow the precautions listed below:

- Limit your movement. Movement can cause static electricity to build up around you.
- Handle the device carefully, holding it by its edges or its frame.
- Do not touch solder joints, pins, or exposed printed circuitry.
- Do not leave the device where others can handle and possibly damage the device.
- While the drive is still in its anti-static package, touch it to an unpainted metal part of the system unit for at least two seconds. (This drains static electricity from the package and from your body.)
- Take additional care when handling devices during cold weather, as heating reduces indoor humidity and increases static electricity.

This book provides information about the USB 1.44 MB External Diskette Drive, including how to properly install the diskette drive and its AIX drivers. Use this book along with your specific system unit and operating system documentation.



## Chapter 1. Overview

This chapter describes the features of the USB 1.44 MB External Diskette Drive and provides instructions for handling and installing the drive. The drive is a 3.5-inch, double-sided, micro floppy disk drive with the following features:

- Full-speed data transfer rate of 12 Mb per second
- 300 rpm disk rotational speed
- Fully hot-pluggable
- Track density of 5.3 per mm (135 tpi)
- Supports the following modes:
  - Format/read/write in 1.44 MB mode on 2 MB High-Density (2HD) diskettes
  - Format/read/write in 720 KB mode on 1 MB Double-Density (DD) diskettes

#### **Other Handling Considerations**

Be sure to take the following additional precautions when you use the diskette drive:

- · Remove diskettes before moving the drive.
- · Do not place the drive where any of the following conditions exist:
  - High temperature
  - High humidity
  - Excessive dust
  - Excessive vibration or sudden shock
  - Direct sunlight
- When in use, keep the diskette drive in a horizontal position. Do not install the drive vertically or invert the drive while it is running.
- Do not insert foreign objects into the drive.
- Do not stack objects on the drive.
- · Do not remove the drive covers or attempt to service the drive yourself.

#### **Handling Diskettes**

Diskettes are high-density media that must be handled with care to ensure that they remain readable. Use the following precautions to ensure reliability:

- Hold the diskette by its edges.
- Do not touch the media inside of the diskette case or attempt to open the case.
- · Do not store or place the diskette in direct sunlight.
- Do not bend the diskette.

#### Loading a Diskette

To load a diskette into the drive, do the following:

- 1. Position the diskette with the media spindle facing down.
- 2. Insert the diskette into the drive until it snaps into place. When the diskette is fully seated, the Eject button will extend outward from the front of the drive.

### **Ejecting the Diskette**

To eject a diskette, do the following:

- 1. Press the Eject button above the diskette slot. The diskette will partially eject from the drive slot.
- 2. Gently remove the diskette from the drive and place it in a secure area.

# Chapter 2. Preparing to Install the USB 1.44 MB External Diskette Drive

This chapter describes how to prepare to install your USB 1.44 MB External Diskette Drive. Preparing to install the diskette drive involves the following tasks:

- · Verifying your hardware and software requirements
- · Making sure your package is complete
- · Gathering tools and documentation

#### Verifying Your Hardware and Software Requirements

To install the USB 1.44 MB External Diskette Drive, you must have a USB Type A port on your system. A USB Type A port looks similar to the following:



The following limitations also apply:

- Do not connect the diskette drive to an external USB hub, either powered or nonpowered.
- No more than one external diskette drive may be attached per adapter.

The USB 1.44 MB External Diskette Drive is supported on AIX 5.2 and later. Ensure that your operating system supports this diskette drive before proceeding. Contact your service representative for assistance.

#### **Checking Your Package**

Check that your package contains the following items:





- Diskette Drive
- USB Extension Cable

If an item is missing or damaged, contact the place of purchase. Be sure to retain your proof of purchase, as it might be required to receive warranty service.

#### **Gathering Tools and Documentation**

No special tools are needed to install this diskette drive. However, you might need the following items:

- · System unit installation documentation
- · Operating system documentation

## Chapter 3. Installing the USB 1.44 MB External Diskette Drive

This chapter takes you through the steps of installing your USB 1.44 MB External Diskette Drive.

#### **Handling Recommendations**

For optimum performance, always follow these recommendations:

- Handle the drive carefully and by its external chassis. Keep your hands away from any printed circuit boards, components, and printed circuit (flex) cables.
- If possible, work on a cushioned surface, and do not drop the drive onto the work surface.
- If you move the drive to an environment that is colder or warmer than its previous environment, keep the drive in its package and allow the package to reach the current room temperature. Allow one hour of acclimation for each 10 degrees C (18 degrees F) difference between the ship or storage temperature and the room temperature.

**Attention:** Your diskette drive requires high-quality media and must be installed in the cleanest possible environment. Improper use, storage, or handling of the diskette drive or media may void your warranty or service agreement. Additionally, your system supplier may only support media they sell. If your service representative determines that a problem is related to use of inferior-quality media, replacing the media will be the responsibility of the customer.

#### Installing and Connecting the USB 1.44 MB External Diskette Drive

The USB 1.44 MB External Diskette Drive must be connected directly to your system adapter through a Type A USB port. Do not connect the diskette drive to an external USB hub, either powered or nonpowered.

No power cable or additional power outlet is necessary because the drive draws its power directly from the USB port on your system adapter.

To install and connect the drive, do the following:

- 1. Place the diskette drive in a secure position where it can lie flat and be easily accessible.
- Plug the USB connector cable on the drive either directly into the USB port on the adapter or the USB extension cable that was provided with the drive. If using the extension cable, then plug the connector on that cable directly into the USB port on your system adapter.
- 3. Route any loose cable away from potentially high-traffic areas and secure it with cable ties, if necessary.
- **Note:** The diskette drive is supported as a hot-pluggable device. However, before using the drive, proceed to the next section for information about how to enable the device on an AIX system.

## Chapter 4. Using the Diskette Drive

USB device driver software is provided within AIX and other operating systems. In most cases, you need only to run the cfgmgr command to enable the diskette drive on your system.

To determine whether the correct AIX device driver is installed, run 1sdev -P -t 080400 at the system prompt. If the driver is installed, output similar to the following is displayed:

diskette 080400 usbif USB Diskette Drive

If the driver is not shown, you must install it from your disc media. Follow the procedure outlined in Installing Device Drivers on an AIX System.

#### Using Configuration Manager to Enable the Diskette Drive

To configure the diskette drive on an AIX system containing the supporting USB device drivers, do the following:

- 1. Log in as root user.
- 2. At the system prompt, type cfgmgr -v and press Enter.

If the drive does not function correctly, run diagnostics to determine the reason for the error and repeat this step.

#### Installing Device Drivers on an AIX System

If you must install non-AIX resident device drivers on your system, do the following:

- 1. At the system prompt, log in as root user.
- 2. Insert the device driver media into the appropriate media device.
- 3. To start SMIT, type smit devinst at the prompt, then press Enter. The Install Additional Device Software panel displays. The INPUT device/directory for software option is highlighted for selection.
- 4. Press F4 to display a list of input devices from which you can select. The cursor is already positioned on the input device entry field.
- 5. Either type the name of the input device in the entry field or select the appropriate device, then press Enter. The Install Additional Device Software panel displays the device you selected in the INPUT device/directory for software field. The SOFTWARE to install option is highlighted.
- 6. Press F4 to display a list of the device packages you can install.
- 7. To display a Find dialog box, type / in the field where the cursor is positioned.
- 8. Select the following device package name: devices.usbif.080400 and then press Enter.
- 9. Press F7 to select the device package name, then press Enter. The Install Additional Device Software panel displays the completed required fields.
- 10. Press Enter. The ARE YOU SURE list displays.
- 11. Press Enter. The COMMAND STATUS panel displays. The term RUNNING is highlighted, indicating that the software is being installed and configured.
- 12. When RUNNING changes to 0K, scroll to the bottom of the panel and locate the Installation Summary. If the installation was successful, SUCCESS displays at the bottom of the panel in the Result column of the Installation Summary.
- 13. Remove the device driver software media from the media device.
- 14. Press F10 to exit SMIT.

- 15. Either shut down and restart your system using the shutdown -Fr command, or use thecfgmgr command to enable the diskette drive.
- 16. To check whether the driver installation was successful, type smitty at the system prompt.
- 17. Select Select Devices -> Diskette Drive -> List all Defined Diskette Drivers.
- 18. Verify that the diskette drive is Available.


